Sir,

In producing herewith one arrested person namely (1) Sumit Thakur (19) S/O- Lt Basudeb Thakur of Nabogram, Near Sri Sakti Kali Mondir PS- NJP, Dist- Darjeeling, arrested along with following articles along with proper seizure list.

- 1) 14(Fourteen) Plastic bottles of Himalayan Gold country sprit 60 UP, containing 600 ml each bottle.

I ASI Debasish Das of Siliguri PS, (SPC) would like to lodge this written complainant against the above noted accused person to the effect that on 14.05.2022 at 20:05 hrs myself along with ASI Siben Sarkar and force CV/283 Prasenji DeyCV/ 622 Rama Barmon left PS for Special mobile van duty vide Siliguri PS GDE No. 819/22 Dated- 14.05.2022. During mobile duty at about 21:10 Hrs I received information that one person namely Sumit Thakur selling huge quantity of illegal liquor selling at the Bagra Court Bazar back side of bus stand under Siliguri PS. Accordingly, I shared the information to you and as per your kind instruction myself along with force rushed to the spot and held raid at the Bagra Court Bazar back side of bus stand and detained the above noted person and on searching recovered above noted articles from a hand bag which bag found from his possession. On demand he failed to produce any valid document in favor of the recovered articles. On interrogation he admitted that he had been selling the same illegally since long time without any valid document for his illegal gain. Accordingly, I seized the above noted articles under proper seizure list and labeled in between 21.40 hrs to 22:05 hrs and arrested him with proper memo of arrest.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely (1) Sumit Thakur (19) S/O- Lt Basudeb Thakur of Nabogram, Near Sri Sakti Kali Mondir PS- NJP, Dist- Darjeeling and arrange for its investigation.
