In producing herewith one accused person namely Semonto Das (30/M) S/O Late Pradip Das of Bandri Jote, near Delhi Public School, PS- Pradhannagar Dist- Darjeeling along with 15(fifteen) bottles of Himalaya Gold 60up Country spirit each bottles containing 600 ml. & MRP Rs 120/- each bottle Total RS.1800/-

I ASI Kala Chand Singha of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 14.05.2022 at 17:25 hrs. received an information from Ramghat Below the Bridge, W/NO-05, PS- Siliguri, Dist- Darjeeling that one person has gathered huge quantity of illegal liquor for selling the same in the open market for his wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO - 303 Dated-14.05.2022. As per your kind instruction myself along with ASI Uttam Kumar Dhar, C/874 Nagen Gurung CV/05 Gobinda Das and proceeded to the PO to work out the information. At 17:45 hrs. we reached at the Ramghat, Below the bridge, W/NO-05 some times after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell same in open marked for his wrong full gain. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizer list and level and took signature of the accused person one bottles taken as sample .The seizure was made in between 17:50 hrs. to 18:35hrs. I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Semonto Das (30/M) S/O Late Pradip Das of Bandri Jote, near Delhi Public School, PS- Pradhannagar Dist- Darjeeling under proper section of law and arrange for investigation .
