I Rinku Gupta W/o Manoj Kumar Gupta, D/o Sri Lalan Prasad Gupta, resident of Tribeni Toll, Jaigaon, P.O. & P.S.-Jaigaon, Dist-Alipurduar, would like to inform you that my marriage was solemnized on 22.02.2016 with my husband namely Manoj Kumar Gupta S/o Sri Ram Dular Gupta, resident of Narmada Bagan, Anchal Champasari, Siliguri, P.S. Pradhan Nagar, Dist. Darjeeling according to Hindu rite, ritual and Customs in presence of Guardian, Well wisher and friends at Sahu Bhawan, Bow Bazar, Jaigaon, P.S. Jaigaon, Dist. Alipurduar and after marriage I lead conjugal life in matrimonial house at Narmada Bagan, Anchal Champasari, Siliguri and after wed-lock one female child was born namely Aroshi Gupta now aged about 3^{1/2} years and after few years of my Marriage my husband Manoj Kumar Gupta S/o Sri Ram Dular Gupta and all in-laws namely 1.Ram Dular Gupta (Father-in-law)S/o Late Bal Govind Gupta, 2.Sail Kumari Devi (Mother-in-law) W/o Sri Ram Dular Gupta,3.Dilip Kumar Gupta (Brother-in-law) S/o S/o Sri Ram Dular Gupta and 4.Smt.Punam Kumari Gupta (Jethani i.e. Sister-in-law) W/o Sri Dilip Kumar Gupta all are resident of Narmada Bagan, Anchal Champasari, Siliguri, P.S. Pradhan Nagar, Dist. Darjeeling all were changed their behaviour and abusing and always my Jethani Punam Kumari Gupta instigates my in-laws against me without any reason and she assaulted me and by all in-laws and taunts everything on every day and she humiliates all the time and treats me as servant for all job in the matrimonial house and always provokes my husband against me and does not let him sit with me and My Jethani always taunts for not given proper Dowry at the time of marriage from my Parental side and for this Commits mental and physical torture and atrocities on this matter and gets it done by the Whole in-laws and my husband also torture mentally and physically on this matter and for this on 17.09.2021 my husband, Jethani and other in-laws badly assaulted and mental torture thereafter on 15.10.2021 my Jethani forced my two months old foetus miscarriage under criminal conspiracy with in-laws and I tried to protest but they did not agree thereafter I inform to my father who tried to settled to explain my husband and in-laws but all in vain thereafter on 28.11.2021 I was demanded Rs.10,00,000/-(Rupees ten Lakhs) cash amount for their business from me and will not let me stay in in-laws house, if I do not give, when I refused, they hit me very badly and damaged my all goods and furniture, thrown out side and all in-laws behaviour are not good.....
