In producing herewith one Md Abbas 25yrs s/o Late Mushahid Hussain R/o Doa Bisua PO, Panishala hat PS, Raiganj Dist, Uttar Dinajpur along with following seized articles viz,

- i. 115 (one hundred fifteen) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Ethcorex -CD cough syrup Anti Allergic, Anti Tussive, For Dry Cough having Batch no - NLA2214 Mfg Date 01/22 Exp Date 12/23 and MRP Rs, 125.00. Each bottle content 100 ml, marked as exhibit- "A". Total 11,500 ML
- ii. 01 (One) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Ethcorex -CD cough syrup Anti Allergic, Anti Tussive, For Dry Cough having Batch no - NLA2214 Mfg Date 01/22 Exp Date 12/23 and MRP Rs, 125.00 content of 100 ml, taken from SL no - I as sample for examination marked as exhibit- "A-1".
- iii. One big size black color synthetic bag with handle which was used for carrying SL no - I
- iv. One Two wheeler Motor Cycle black color styled as Apache RTR 160 bearing registration no WB60X/9746
- v. One blue color Android Mobile hand set styled as "POCO" having one SIM bearing no 8927952852.

I, SI Lawang Bomzon of Bagdogra Ps, Siliguri Police Commissionerate do here by lodged this complaint against Md Abbas 25yrs s/o Late Mushahid Hussain R/o Doa Bisua PO, Panishala hat PS, Raiganj Dist, Uttar Dinajpur to the effect that on 16.05.22 at 18-25 hrs received a secret source information that one male person aged approx 25/28 yrs having possession of huge quantity of restricted drugs (Cough Syrup) who was coming from Ghoshpukur side by a two wheeler motor cycle black color styled as Apache RTR 160 bearing registration no WB60X/9746 and he could be caught red handed if apprehended immediately. The matter was diarized vide Bagdogra Ps GDE No-770 dt- 16.05.22. Accordingly, I informed the matter to O.C, Bagdogra PS. As per his instruction myself along with ASI Jakurul Islam, ASI Khagen Barman, C/1008 Kanak Roy, VP- 01 Ansalam Kujur, CV/375 Jogesh Barman and CV/386 Kishor Ranjan Howlader left for the Bhuttabari More for spl Naka Checking. At 18.30 hrs hrs to verify the veracity of the information vide corresponding Bagdogra Ps C.C No- 2160/22 Dtd, 16.05.22.

At the time of departure from Police Station, I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc. On way to spot at Bhuttabari Bagdogra Airport More meanwhile I called two independent witnesses namely [1] Tapash Barman 29yrs s/o Late Lalit Barman of Gosainpur Rupsingjote Ps Bagdogra Dist. Darjeeling and [2] Mirajul Seikh 49yrs s/o Late Azizul Seikh of Bhuttabari More Ps Bagdogra Dist. Darjeeling P/A Debkundo Baganpara PO, Debkundo PS, Beldanga Dist, Murshidabad informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 18.45 hrs on arrival there by govt. vehicle as started special Naka checking to upcoming all the two

wheeler Motor Cycle black color styled as Apache RTR 160 bearing registration no WB60X/9746, at around 18.55 hrs identified by the source in street light one two wheeler Motor Cycle black color styled as Apache RTR 160 bearing registration no WB60X/9746 coming from Ghoshpukur side we signal him for stop seeing the police the motor cycle rider tried to flee away a hot chase somehow we managed to apprehended the two wheeler Motor Cycle black color styled as Apache RTR 160 bearing registration no WB60X/9746 at Bhuttabari More who carry one big size black color synthetic bag hang on his vehicle. On being asked he disclosed his identity as noted above. On being further asked he stated that the content inside the bag is restricted Drug Cough Syrup. After disclosing our identity, I asked them whether he wanted to be searched in presence of Spl, Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him option notice accordance with provisions of law u/s 50 of NDPS Act in this regard in writing and he also gave his approval of being searched by any one in writing in the notice serve to him. Accordingly, I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sri Narendra Kalicotay, ACP SB, SPC, who was Spl, Executive Magistrate on the day. Accordingly, I informed to Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and request him to came down at the spot. At about 19.35 hrs Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and O.C. Bagdogra Ps arrived at the spot. I disclosed the identity of Sri Narendra Kalicotay, ACP SB, SPC, to the accused person as Spl, Executive Magistrate and also witnesses. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But he refused to search the police party. Under supervision of Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and in presence of independent witnesses I conducted searched the detained person following all formalities keeping his decency but nothing could be recovered on him person except wearing appajels. Then searched the black color synthetic bag which he was carrying on his two wheeler motor cycle hang on the left side and found the above noted seized restricted drugs (Cough Syrup) inside in the black bag. On demand in presence of the Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC he failed to produce any valid document in support of possessing of the restricted drugs (Cough Syrup) which was kept inside in the black color bag.

I accordingly counting the restricted drugs (Cough Syrup) total 115 (one hundred fifteen) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Ethcorex -CD cough syrup Anti Allergic, Anti Tussive, For Dry Cough having Batch no - NLA2214 Mfg Date 01/22 Exp Date 12/23 and MRP Rs, 125.00. Each bottle content 100 ml, marked as exhibit-"A". Total 11,500 ML, Marked as Exhibit -"A" and 01 (One) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Ethcorex -CD cough syrup Anti Allergic, Anti Tussive, For Dry Cough having Batch no - NLA2214 Mfg Date 01/22 Exp Date 12/23 and MRP Rs, 125.00 content of 100 ml, taken from SL no - 1 as sample for examination marked as exhibit-"A-1". I labeled and sealed all the article in presence of Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and independent witnesses and accused person. Then, I seized the above noted articles under proper seizure list and label duly signed by the above noted witnesses and the Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and acknowledged by the accused person. The seizure was made between 19.55 hrs to 20.25 hrs. On further asked the apprehend person confessed in presence of Spl, Executive Magistrate Sri Narendra Kalicotay, ACP SB, SPC and other witnesses that he procured the said restricted drugs (Cough Syrup) total 115 (one hundred fifteen) bottle of Chlorpheniramine Maleate & Codeine Phosphate Syrup, Ethcorex -CD cough syrup Anti Allergic, Anti Tussive, For Dry Cough clandestinely for the purpose of selling in order to earn huge money quickly.


On interrogation he disclosed that he had been dealing in such business for last few years importing from Raiganj, Malda and selling the same Siliguri Panitanki Nepal area. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to above noted accused person under proper receipt as the accused person violated the terms and condition of NDPS Act possessing restricted drugs (Cough Syrup) without any authority.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Md Abbas 25yrs s/o Late Mushahid Hussain R/o Doa Bisua PO, Panishala hat PS, Raiganj Dist, Uttar Dinajpur and arrange for its investigation.
