I, Jamshed Ali Molla resident of 17, Colonel Biswas Road, Kolkata 700019 would like to state that I have a company named Sunny Rock Estates and Developers Pvt. Ltd. having its registered office at 17, Colonel Biswas Road, Kolkata 700019, also having a land measuring 3.32 Acres in Mouza Binaguri J.L. No. 3, P.S. Rajganj, Dist- Jalpaiguri which has already been transferred in favour of Housing Board as Assisted Sector Company without any consideration.

That on 6.05.2022 (6th May 2022) on my instruction my person had gone to inspect the land mentioned above and on reaching the said spot, was shocked to see that the above named pupil were present in the said premises and the said property was encroached by way of illegal occupancy

The said property was occupied by the above mentioned people who were present in the said premises and had occupied the land by way of constructing bamboo hut, and when my person enquired, the said people they became violent and obstructed my person from obtaining from any information from the said culprits as named above.

My person was taken hostage and was given an ultimatum to surrender his life and call me demanding Rs. 3CR. (Rupees Three crores), failing which his family will be killed, to which he surrendered keeping his family in mind and he chose to be beaten up brutually to save his children and wife and got severely injured on his head and body. They even snatched his gold chain from his neck and wallet which had an amount of Rs. 5500/- (Rupees Five Thousand Five Hundred)only and

Further to my submission the above named people became violent and took out iron rods and bamboo stick to paralyse the entire situation. Finally, when my person didn't sucumm to the pressure he was shown Pistol by the people named above, where 2 rounds were fired at my person but he managed to survive, on hearing such peculiar sound the people nearby rushed in where he escaped and was saved from getting killed.
