Through this application I want to inform you that my husband's death was due to kidney failure. After which the husband's parents, and other relatives who don't want to look after me and my daughter, so, I stay in a rented house. Whenever I try to get my share from my husband's family they use slang languages and start scolding and beating me and my daughter at present my daughter is only twelve years old. My husband's relatives divided the property among themselves without giving any shares of my husband and did not inform me for the division.

I along with my 12 years old daughter lives in very critical condition in rented house. No one is looking after me and my daughter.

Please take necessary steps against the people who are threatening me and my daughter. I would be thankful to you for this sort of work for me.
