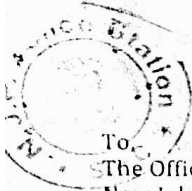

 In producing herewith the one arrested accused person namely Rahul Das (22) s/o Goutam Das of Nougkhat, near Netaji Club, PS- NJP, Dist.- Jalpaiguri along with the following seized articles under proper seizure list.

1. One Blue Color Scooty style as DIO bearing registration No.- WB/74/AN/9425

I, SI Gautam Laskar of New Jalpaiguri PS, Siliguri Police Commissionerate do here by lodged this written complaint against the above noted persons to the effect that today on 13.05.2022 as per the detailment Myself along with Officer and Force namely SI Shib Shankar Das, LPSI Supriya Barman, ASI Bhai Chandra Tamang, ASI Dhurba Mishra, ASI Rabi Tamang, C/788 Majnu Rahaman, C/230 Subhash Chandra Roy, C/77 S. Oroan, LC/328 Punam Roy, C/1325 Mamta Roy, CV/01 Jai Chand Roy, CV/953 Dhanesh Roy, CV/989 Bimal Barman, CV/327 Chiranjit Roy, CV/48 Saidul Haque, LCV/351 Sushila Roy, LCV/331 Iron Bala Roy all of Siliguri Police Commissionerate vide New Jalpaiguri PS SPL CC No.- 828/22 dated: 13.05.2022, reference New Jalpaiguri GDE No. 640 dated: 13.05.2022 while performing Special Naka duty at Nougkhat More, under New Jalpaiguri PS, Siliguri Police Commissionerate at about 2215 hrs One Scooty style as DIO bearing registration No.- WB/74/AN/9425 come from the Nougkhat Bridge towards Siliguri Side without wearing helmet. Accordingly Myself along with other detail Officer and Force intercept Scooty Rider and on being asked he disclosed his name and address as noted above. Subsequently, I asked the said Scooty rider to produce relevant documents of the said scooty but he denied to produce any valid documents instead giving reason of being local did not have to produce any documents and also uses abusive languages towards Lady Officer namely LPSI- Supriya Barman and also threatened Police Team with dire consequences. Suddenly the said Scooty Rider started his scooty with high pickup and ride with high and excessive speed and Myself along with other officer and Force tried to stop him but the said Scooty rider tried to fled away from discharging my duty. Hence, Myslef along with detail Officer and Force apprehended the above noted accused person. Accordingly, I seized the above noted Scooty under proper seizure list and arrested him after issuing proper memo of arrest and observing all the guideline issued by the apex court and brought him into NJP PS with seized Scooty. Due to this incident I, received sever injury and treated at Siliguri District Hospital.

Under this fact and circumstances, I pray to you that a specific case may kindly be started under proper sections of law against the arrested accused person namely Rahul Das (22) s/o Goutam Das of Nougkhat, near Netaji Club, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
