With due respect this is to inform you that I Sohail Alam Son of Md Safik residing at New Prakash Nagar, Ward No. 43 P.S. Bhaktinagar, District Jalpaiguri do hereby lodge this complaint as below: -

- That on 07/03/2022 my mother namely Neha Begam committed suicide at our own residential house due to abatement of my maternal uncle Mr. Manoj Kumar Sah due to property related issue.
- 2) That after the said incident my uncle falsely lodge one complainant against myself, my brother namely Abu Sahid, my wife Hena Khatun and my father Md Safik.
- 3) That on 07/03/2022 my uncle along with above noted accused person forcefully came into our house and assaulted myself, my father, my brother and my wife Hena Khatun and accused No. 10 snatch one gold chain from my wife's neck. They broken our house door, broken all the furniture, almirah, locker etc.
- 4) That my brothet Abu Sahid also run a business mobile phone repairing business from my house. They also taken some mobile phone from my brother's shop which are (1) one Real me C25Y IMEI no. 863473054244038, 863473054244020, (2) one Red MI MI A1 (3) one RealMe C2 (4) Nokia 6.1 Plus (5) one Iphone 5S (6) two Samsung Galaxy J7 (7) one Samsung Galaxy J2 (8) one Jio Phone Key pad.
- 5) That there after police came to my house and arrested myself, my brother Abu Sahid, and my wife Hena Khatun.
- 6) It is stated that after our arrest nobody stayed in my house.
- 7) That there after my uncle came in my house and taken one welding machine, one nos of Drill Machine, one Nos of Cutter Machine, Hammer, Iron rod, 6 nos of Steel bed etc. from my work shop which is attached in my house and some Bronze Utensils etc.
- 8) That after got bail from the court on 12/05/2022 I return back to my house and found that the entire article scatter in my room and locker has broken. That after our arrest my uncle along with some people came in my house and taken the ornaments, cash and Bronze Utensils and my vehicle bearing no. HONDA AMAZE WB74AX5664 is also broken by the accused person and they damage our shoecase, almirah, iron bed etc..

9) That this was happened due to my uncle and above noted accused person in absence of us.

Under the above circumstances it is prayed that kindly take necessary action as per law against accused person mentioned above as may deem fit and proper.
