Sir,

In producing herewith one (01) arrested accused person namely Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim along with the following articles under proper seizure as per seizure list;

- a. 12 (twelve) bottles of "Onereex" Cough Syrup (each bottle containing 100 ml) having Batch No. 191121-SD28, Mfg. Date: 11/2021. Exp. Date: 10/2023, seized from the Exclusive and conscious possession of above noted Saran Pradhan (32) and marked as "Exhibit- A".
- b. 72 (seventy-two) strip of Winspasm-Forte capsules each strips containing 08(eight) capsules Total (72 X 8- 576) capsules. Each capsules weight 385 gm. Total 385 X 576 = 221.76 gm Seized from the Exclusive and conscious possession of above noted Saran Pradhan (32) and marked as "Exhibit- B"
- c. One multi-colour plastic carry bag.
- d. One four wheeler (Tata Sumo Gold) bearing registration No- SK 02 J 0777.
- e. One driving licence bearing no SK04 2016 0003523 validity up to 13.10.2036 in respect of Saran Pradhan.

I, Binod Singh Rawat of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim to the effect that on 16.05.2022 at about 17.25 hrs I received a specific source input that one person, possessing huge quantity of 'Codeine Phosphate' based drugs, was going towards Sikkim in a car (tata sumo gold) bearing registration No- SK 02 J 0777 from Siliguri via By-pass road to sell the same to his designed customers. The matter was diarized in Bhaktinagar PS GDE No. 927 Dt. 16.05.2022 and subsequently, I informed the matter to the Inspector-in-Charge, Bhaktinagar Police Station in written and being directed, myself along with ASI Dipak Karmakar, Const- 986 Rajib Sarkar and CV/619 Dharmendra Roy CV/ Biplab Barman all of Bhaktinagar PS, SPC along with investigation kit left for by-pass more by Govt. vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE No. 928 Dt.16.05.2022 and M.C.C No- 1518/2022 Date- 16.05.2022.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On By-pass more near check post under Bhaktinagar PS I contacted two persons namely (1) Kamal Ch Mallick S/O- Lt Sambhu nath Mallick of Vill+P.O-Ulladabri, P.S-Maynaguri, Dist-Jalpaiguri and (2) Avijit Das S/O- Avinash Das of Jyotinagar, ward no -4, P.S- Siliguri, Dist- Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses stand By-pass more near check post under PS- Bhaktinagar at 19.35hrs and subsequently, being pointed by my source detained 01 (one) vehicle (four wheeler) Tata Sumo Gold bearing registration No- SK 02 J 0777. After detention of vehicle we searched and found one multi-colour plastic bag under his driving seat. Thereafter, we disclosed our identity and the information in hand and stated him that he as well as the bag under his possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but he did not search the police party. Consequently, I informed the matter to I/C Bhaktinagar PS regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at By-pass more near check post under Bhaktinagar PS to remain present and to supervise the search and seizure.

Accordingly at 19.55 hrs Shri Amaresh Singh I/C Bhaktinagar PS acting as Gazetted officer of SPC arrived at the spot at By-pass more near check post under Bhaktinagar PS as Gazetted officer, SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping her decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim

On being searched of the said detained person found 12 (twelve) bottles of "Onereex" cough syrup (each bottle containing 100 ml) containing 12 X 100 ml = 1200 ml i.e., equivalent to 1.2 Kgs. and 72 (seventy-two) strip of Winspasmoforte capsules each strips containing 08(eight) capsules Total (72 X 8 = 576) total 221.76 gm capsules which was kept into a plastic bag carried by the detained person namely Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim

Further, on demand in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer of SPC the detained person namely Saran Pradhan(32) failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed limit.

Thereafter, I seized the recovered 12 (twelve) bottles of "Onereex" cough syrup (each bottle containing 100 ml) containing 12 X 100 ml = 1200 ml i.e., equivalent to 1.2 Kgs. and 72 (seventy-two) strip of Winspasmoforte capsules each strips containing 08(eight) capsules Total (72 X 8 = 576) capsules from the exclusive and conscious possession of above noted accused person at the spot at By-pass more near check post under Bhaktinagar PS under proper seizure list in presence of independent witnesses and Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for acting as Gazetted officer, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for Gazetted officer, SPC and independent witnesses and the accused person namely Saran Pradhan(32) The whole process of seizure was made in between 20.05 hrs to 20.35hrs.

Being further asked, the apprehend persons namely Saran Pradhan(32) admitted in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer of SPC and other independent witnesses that he has procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. She also disclosed that he has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last few months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Saran Pradhan(32) is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim  
After observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Saran Pradhan(32) S/O- Prem Pradhan of Phalidara, P.O+P.S- Namchi, Dist- South District, State- Sikkim and arrange for its investigation.
