In producing herewith one arrested accused person namely Gaisal Rajak (22) s/o Manoj Rajak of Sir, Jabravita, PS- New Jalpaiguri, Dist.-Jalpaiguri along with seized articles viz.

1] 20 (Twenty) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 12 liters, value Rs.120X20=2,400/-), and marked as 'exhibit -'A'.

2] 18 (Eighteen) bottles of 70 Up Country Spirit style as BAZIGAR (each bottle containing 300 ml, Total 5.400 liters, value Rs. 38X18=684/-), and marked as 'exhibit - 'B'.

I, PSI Pradeep Diylai presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (14.05.2022) at 17.15 hrs myself along with officer and forces of NJP P.S, SPC left P.S for special raid duty vide NJP P.S GDE No. 685 Dtd. 14.05.2022. On the way I receive a specific source information that one person namely Gaisal Rajak (22) s/o Manoj Rajak of Jabravita, PS- New Jalpaiguri, Dist.- Jalpaiguri has stored huge quantity of Illegal liquor at his shop without any valid license. Acting on source information, myself along with ASI Sajal Das, VP/ 13 Jamirul Islam, CV/306 Biswajit Roy and CV/824 Niru Kr Yadav all of New Jalpaiguri PS, Siliguri Police Commissionerate had been to Jahbravita at the shop of Gaisal Rajak (22) s/o Manoj Rajak of Jabravita, PS- New Jalpaiguri, Dist.- Jalpaiguri and found that the aforesaid person had been selling illegal liquor to the common customers at his shop at Jabravita area under New Jalpaiguri PS jurisdiction. Then I cordoned the place with my accompanied forces and apprehended the above noted person and on being asked disclosed his identity as noted above and stated that he used to sell illegal liquor at this place for his wrongful gain since very long. On being search of him in presence of available witnesses the above noted seized articles are found inside a bag from his conscious possession. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person after issuing proper memo of arrest and observing all the guidelines issue by the apex court. While on the time of cordoning off the place, the persons who were having liquor at that place manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 18.15 hrs. to 18.55 hrs.

Under this above fact and circumstances, I pray before your good self that a specific case against the above noted accused person namely Gaisal Rajak (22) s/o Manoj Rajak of Jabravita, PS- New Jalpaiguri, Dist.-Jalpaiguri may kindly be initiated under proper section of law and may cause for its investigation.
