Sir,

In producing herewith one arrested accused person namely Moni Kumar Chhetri (30 yrs), S/O Mon Bahadur Chhetri of Farabari Nepali busty PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Nineteen (19) sealed Bottles of 60 UP pet Himalayan Gold Country Sprit each bottle containing 600 ML.

I, ASI Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 14.05.2022 at 19:05 hrs received source information that the above noted person has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE 546 dated 14.05.2022. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) C-505 Tapash Dutta (2) C/824 Satyaban Das (3) ASI Biswajit Ghosh all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Farabari Nepali busty to work out the information. At 19:35 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Farabari Nepali busty at the House of Moni Kumar Chhetri and recovered the above noted articles from the possession of accused person namely Moni Kumar Chhetri (30 yrs) S/O Mon Bahadur Chhetri of Farabari Nepali busty PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o. Lt. Narayan Saŕkar of Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19.55 hrs to 20.15 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Moni Kumar Chhetri (30 yrs), S/O Mon Bahadur Chhetri of Farabari Nepali busty, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri under proper section of law.
