Sir,

In producing herewith one arrested accused person namely i) Md Raja Hashmi (23) s/o-Md Munna Babu Hashmi of Gurung Basti, W/N-03 PS-Pradhannagar Dist-Darjeeling along with seized items as follows;

- i) 03 Cartoons of ETHCOREX Cough Syrup containing 100 bottles each. Each bottle contains 100 ml which contains mixture of 10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg, (Total bottles 300 Pieces) Each bottle MRP RS. 165/- and marked as Exhibit-A and taken one bottle from one cartoon as sample marked as Exhibit-AI
- ii) 400 bottles Bpen -C Cough Syrup in a bag contains 100 ml each which contains mixture of 10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg Each bottle MRP RS. 155/- and marked as Exhibit-B and taken one bottle as sample marked as Exhibit-BI
- iii) One cartoon of SPASMO-PROXYVON PLUS capsules, Quantity (65x24x6 capsules=9360 capsules) marked as Exhibit-C and taken as sample one packet quantity (6x24=144 capsules) marked as Exhibit-C1. Each strip of eight capsule Rs-67/- total-Rs-78390/-
- iv) One Scooty Honda Activa-125 CC Bearing Reg No-WB74AR-1281 Gray colour
- v) One mobile Set OPPO blue colour IMEI NO-86390305211699 and IMEI NO-863903052116481 and attached two sim card mob no-9091960910 and 9091635887
- vi) Total cash amount -Rs-1480/-

I SI Nur Alam Siddik of Detective Department, SPC, Siliguri lodge a written complaint to the effect that on 16.05.22 at 12.45 hrs received a reliable source information that the above noted accused person is storing and selling cough syrup and Capsules in a garage named Hashmi Garage situated at near Thakkar Bridge under Matigara PS to the drug addicts at higher prices without prescriptions for his wrongful gain. I diarized the same vide DD, SPC GDE No. 72 Dt: 16.05.22 and informed ACP, DD, SPC. Accordingly on his consent at 13.05 hrs myself along with SI Amartya Chakraborty, SI Swadesh Saha, ASI Praloy Bhattacharjee, ASI Abu Taleb, ASI Ratan Pradhan, Const-371 Sushanta Dey, Const-932 Pabitra Das, Const-945 Krishna Barman left for Hashmi Garage situated at near Thakkar Bridge under Matigara PS vide DD, SPC GDE No 73 Dt: 16.05.22 and CC No-104/22 Dt: 16.05.22 to work out the information. At the time of departure from the office, I took envelope, white paper, sealing wax, gum, seal, official stamp, stamp pad and all necessary requirements.

At about 13.25 hrs, we arrived at near Hashmi Garage situated at near Thakkar Bridge under Matigara PS, as indicated by the source, we entered the garage and found the above mentioned person was arranging several cartoons which were supposed to be taken out of the garage and one scooty Scooty Honda Activa-125 CC Bearing Reg No-WB74AR-1281 Gray colour was standing there. The two persons present near garage being asked to identify themselves disclosed the names as

witnesses (1) Sanjoy Sahani s/o-Suresh Sahani of Santoshinagar near Radhakrishna mandir ,w/n-05 PS-siliguri Dist-Darjeeling (2) Kishan Mukla s/o-Binod Mukla of Hemantabasu Colony w/n-4 PS-Siliguri Dist-Darjeeling . On being asked to justify about their presence in the said garage with those packed cartoons, he could not give any satisfactory answer and confessed that those packed articles were drugs which were obtained fraudulently from somewhere with intension to sell at Siliguri and surrounding areas illegally for his wrongful gain. On demand he failed to produce any documents to support the possession of said drugs.

We then detained him and asked him whether he wanted to be searched in presence of Executive Magistrate or Gazetted Officer and he agreed to be searched by any one of them. Then I called Sri Narendra Kalicotay, ACP SB,SPC as a Special Executive Magistrate to attend at the spot for search and seizure. At 14.15 hrs Sri Narendra Kalicotay, ACP SB,SPC appeared at the spot and gave the identity as Spl executive magistrate before detained person. Then I searched the garage and found i)03 Cartoons of ETHCOREX Cough Syrup containing 100 bottles each. Each bottle contains 100 ml which contains mixture of 10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg, (Total bottles 300 Pieces) Each bottle MRP RS. 165/- and marked as Exhibit-A and taken one bottle from one cartoon as sample marked as Exhibit-AI ii) 400 bottles Bpen -C Cough Syrup in a sack contains 100 ml each which contains mixture of 10mg Codeine Phosphate & Chlopheniramine Maleate syrup 4mg Each bottle MRP RS. 155/- and marked as Exhibit-B and taken one bottle as sample marked as Exhibit-BI iii) One cartoon of SPASMO-PROXYVON PLUS capsules, Quantity (65x24x6 capsules=9360 capsules) marked as Exhibit-C and taken as sample one packet quantity (6x24=144 capsules) marked as Exhibit-C1.Each strip of eight capsule Rs-67/- total-Rs-78390/-

It is seen that all the articles found as mentioned above are prescription drugs which falls under NDPS Act and liable for punishment as per its provision. I seized all the above articles ,scooty mobile and cash amounting rupees 1480/- in a proper seizure list in presence of the witnesses who were accompanying us with proper sealing and labeling which was seized from the possession of the above mentioned accused person. The articles seized are psychotropic substance which is used by the Drug abusers for intoxication. Hence having strong reason to believe that he was committing the offence under NDPS Act. Then I, arrest him by preparing arrest memo and maintained all legal formalities and took him under police custody. **The seizure was made in between 14.40 hrs and 16.45 hrs.** On further interrogation he also confessed he along with few other are running this business illegally.

Hench a specific case may kindly be started against the arrested accused person namely i)Md Raja Hashmi (23) s/o-Md Munna Babu Hashmi of Gurung Basti ,W/N-03 PS-Pradhannagar Dist-Darjeeling and others and arrange for its investigation.
