I Kishan Kumar Rai, s/o Sadeb Roy, resident of Sidhw Kanv Sarani, Hakimpura, Siliguri, under ward no-12, of S.M.C., P.S.- Siliguri, Distt- Darjeeling begs to report you the following fact:-

Kishan Kumar Rai

① That yesterday i.e, 14/5/22 at around 9:15 PM ^{and me} when my brother Kulbant Roy was going towards venus more from the above mentioned address on reaching near venus more a group of 5 to 7 persons including Raj Kumar Rai @ Raja and Swaj Rai @ Rahul both of them are son of Paban Rai was standing there and suddenly the said Raj Kumar Rai @ Raja came in front of the vehicle and started abusing my brother in filthy language saying "WADHAR CHOD DAKH KE NANCHAHA SHAKTA HAI" and when my brother said him not to use such words against him wearing this Raja Kumar Rai took out the sword and tried to hit on my head but fortunately my brother moved from

there and received injury on my
brother's left hand with the said
sword and soon after that the other
brother namely Ganga Raj @ Raju
also came with the hockey stick and
the other five members also came
with deadly weapon such as iron
sword and sticks to hit me and
my brother and started hitting
me and my brother after which
we received severe injuries from
such beating and had a huge blood
loss and after which my brother
fell down and became unconscious
and seen him fell down I called
for help and when the people
near by came for help they all
took the advantage of chaotic
situation and took my brother's
gold chain weighting 10 gm with
22 kadt, and 500/- rupees cash
from his pocket and when they
saw few peoples coming up for
help they fled away from
them and also threatened us
with dire consequences.

① That there after I took my brother to Siliguri district hospital and we both got treated over there.

I therefore request you sir to kindly take necessary legal action as the said Rajkumar Rai @ Raja and Suraj Rai @ Rahul are dangerous in nature and have also given threatening that if we make any complaint against them then they will kill me and my brother and throw us in the river. We are in very much fear sir please take necessary legal action against the aforesaid culprit.
