Pradhan Nagar, District Darjeeling. My husband earlier also did same type act in the year 2016 and I with the help of Matiagar Police caught him from one house at Matigara. He was then arrested and produced at Siliguri Court. I came to know that he had relationship with many girls & ladies. My husband is a teacher Assistant Teacher at Sri Saraswati Hindi Primary School, Raji Jote, Hela Kadam, P.O. & P.S. Bagdogra, District Darjeeling.

It is requested before you to kindly take some steps against my husband so that he can be punished.
