They putted me in fear of rape against me and my daughter and murder.

They had also broked half of my boundary walls but as I screamed for help my neighbour came & stoped them & they ran from the spot & left there toto in front of my gate.

So, therefore I would like to file a case against them on IPC 354 outrage of women with modesty, threat of rape, threat of attempt to murder, threat of throwing acid on my daughter face, intentional use of abusive language amounting to insult, attempt to rape, house breaking, house trespass, criminal trespass.
