Respected Sir,

With due respect I, Sri. Aman Subba, Son of Late Jay Subba, on behalf of my elder brother Sri. Ajay Subba, Son of Late Jay Subba and elder sister Smt. Anju Rai Subba, Wife of Subhash Rai, all are resident of Shastri Nagar, Mother Teresa Road, P.O. Sevoke Road, P.S. Bhaktinagar, PIN- 734001, Dist.- Jalpaiguri, would like to state that we are the joint lawful owner of a plot of land measuring 4 katha, having one small Kuchha room therein with electric connection, appertaining to and forming part of L.R. Plot No. 44 recorded in L.R. Khatian No. 527, 528 and 529, under Mouja- Dabgram, L.R. Sheet No. 44, J.L. No. 2, situated under P.S. Bhaktinagar, Dist.- Jalpaiguri and we are in physical possession of the same. We became the absolute owner of the said land mentioned hereinabove by way of inherited from our grandfather Late Budhman Subba, as the only legal heirs. After inherited the said land we got our name mutated in the L.R. ROR vide Khatian No. 527, 528 and 529 by the B.L. & L.R.O., Rajganj, after following all lawful procedures under the West Bengal Land Reforms Act, 1955.

On 09.05.2022 at about 11:30am some unknown persons, fully equipped with lathi, hammer, etc, broke the main gate of the said land and entered into it forcefully and demolished the said small Kuchha room and also the electric connection. On being informed by one of my well wishers I immediately rushed to the said land and found my room in destroyed condition. Then I came to know after reaching there that they are having hot altercations with the neighbors of our land. Being so resisted by the local people and having found few of my well wishers there one of them angrily instructed his men and persons to demolish the entire boundary wall. However due to strong protest and vivid resistance by my well wishers and neighbors they could not accomplish their entire plan and left the place. However while leaving they threatened with dire consequences that next time they will come with more men and persons including labour & masons and they will raise structure therein.

Under the aforesaid facts and circumstances I request you to find all the unknown persons and take immediate action against them to protect us from being evicted forcefully and unlawfully.
