Sir,

In producing herewith the arrested accused persons namely (i) Ranjit Das (21) s/o Nitai Das of Ghugumali, Ward No.- 37, PS-Bhaktinagar, Dist.-Jalpaiguri (ii) Shakti Das (24) s/o Mahendra Das of Ghugumali, Ward No.-36, PS-Bhaktinagar, Dist.- Jalpaiguri and the following articles under seizure. The ground of arrest duly been communicated with him.

1. One blue color Apache displaying no. WB 74AW 1293
2. One black color Mestro Scooty displaying WB74 AL 8190.
3. One balck color Pulsur displaying No.- WB 62 L 6069.

I, ASI Sajal Das of NJP Police PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused Person to the effect that on 16.05.2022 at 2015 hrs I received reliable secret source information that one (i) Ranjit Das (21) s/o Nitai Das of Ghugumali, Ward No.- 37, PS-Bhaktinagar, Dist.-Jalpaiguri and his associates is proceeding towards NJP side by a stolen Motor Cycle from Asigarh area. Accordingly, I diarized the matter in GD vide NJP PS GDE No 796 Dated 16.05.2022 and informed the fact to you and as per your kind direction myself along with VP/08 Laxman Roy and VP/13 Jamirul Islam all of NJP PS left the PS to verify the veracity of the information. At 2105 hrs we managed to intercepted one motor cycle displaying number plate WB 74AW 1293 at near Jabravita, NJP being driven by one person and assist by corider namely Shakti Das (24) s/o Mahendra Das of Ghugumali, Ward No.-36, PS-Bhaktinagar, Dist.- Jalpaiguri . On being asked they diosclosed their identity as noted above. On demand they failed to produce any documents in respect of the motor cycle in their possessioin. During further interrogation they disclosed that they stolen the said motor cycle form Asigarh area. Accordingly, I seized the said motor cycle under proper seizure list and arrested them under proper memo of arrest and observing all the foirmalities of arrest. After their arrest they further disclosed that they kept another 02 (Two) numbers of stolen Motor Cylce at NJP parking area. Accordingly, as per their leading statement and being shown by them I recovered more 02 (Two) numbers of stolen Motor Cycle displaying number plate (1) WB74 AL 8190 Black Color Mestro Scooty (2) WB 62.L 6069 Black Color Pulsar. Accordingly, I seized the said 02 (Two) numbers of stolen Motor Cycle under proper seizure list. The search seizure and arrest made in between 2115 hrs to 2205 hrs on 16.05.2022

Under the above noted fact and circumstances, I therefore pray to you that a specific case under propedr section of law may kindly be registered against accused namely (i) Ranjit Das (21) s/o Nitai Das of Ghugumali, Ward No.- 37, PS-Bhaktinagar, Dist.-Jalpaiguri (ii) Shakti Das (24) s/o Mahendra Das of Ghugumali, Ward No.-36, PS-Bhaktinagar, Dist.- Jalpaiguri and arrange for its investigation.
