Dear Sir,

I, Sri Shunny Gupta, son of Sri Hriday Narayan Gupta, resident of Satyajit Nagar, Tea Auction Road, Post Office and Police Station- Pradhan Nagar, Pin- 734003, District- Darjeeling, beg to lodge this complaint as follows:

1. I acquired the land measuring 44.50 Decimals appertaining to and forming part of L.R. Plot nos. 99/476, 100/477 corresponding to R.S. Plot no. 99 and 100 at Mouza- Lalitabari, Police Station- Bhaktinagar, Pargana- Baikunthapur, District- Jalpaiguri vide a registered Deed of Sale being no. I-1455 for the year 2013 registered at the office of the erstwhile ADSR Rajganj.
2. In the year 2017, one Jahangir Ali, son Late Habibar Rahman, resident of Lalitabari, Post Office- Menghora, Police Station- Bhaktinagar, District- Jalpaiguri, Pin 735135 first tried to encroach upon my aforesaid land illegally claiming to be the owner of the same, leading to numerous proceedings having been initiated by myself and my father against said Jahangir Alam.
3. Primary among the aforesaid legal proceedings is a civil suit having been instituted by us against said Jahangir Alam in the court of the Ld. Civil Judge (Junior Division) 1<sup>st</sup> Court at Jalpaiguri, being Title Suit no. 266 of 2017, in which an order of "status quo" is subsisting as on date.
4. I am to mention here that my chain of title as regards the aforesaid land measuring 44.50 Decimals is clear and the same finds source firstly in R.S. Khatian no. 23 of Mouza- Lalitabari, Police Station- Bhaktinagar, Pargana- Baikunthapur, District-
