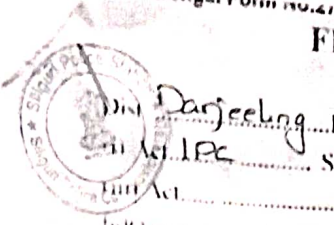

Respected Sir,

I Sarathi Rishi, D/o of Late Khagen Rishi, residing Santoshi Nagar, Ward No 5, Near Santoshi Mandir, District Darjeeling, PS Siliguri, beg to respectfully inform you that on dated 01/04/2022 I filed a F.I.R at Siliguri Women Police Station against a person named Binay Singhania residing of Khalpara, Ward No 9, Siliguri. Police take my F.I.R and filed case (case no.52/2022 U/S 498A/417 IPC) but now the accused Binay Singhania getting anticipatory bail from court, on dated 12.05.2022 Thursday almost 3' o clock day the accused Binay Singhania threatened me in phone call that I have getting bail the power of money, now my father gets bail in few days, then I will make you miserable and told me to get murdered me he force me to leave the city when I go to his home to know about the reason of threat then he and his uncle Narayan Singhania push me and saying slang languages also say that I am a market women who doing bad work for money they hold my hair badly. He threatened me that he want even let me work anywhere. Madam, I am very poor woman and doing work as a maid in people's homes, I live in alone I am scared that he might harm me after this case many people called me and being pressurized for case dismiss I also filed a F.I.R on dated 21-04-2022 againts Bikash Sharma @ bittu but no one punished by police. So I requested you that Binay Singhania and his father bail should be cancelled and give me justice, please take strict action against Binay Singhania and his family member who have wronged behave with me. I highly obelidged with you.
