Siliguri, Distt - Darjeeling, beg to inform you that on Dr. 17.05.2022 at about 10:30 pm, when I was along with my father, namely Jiten Roy (65) S/O Lt. Santosh Roy, of above noted address, saw that the following persons namely (1) Md. Kabul S/O Not known & (2) Md. Pappu S/O Mansur Ali, both are resident of 2 No Gali, Naharpura, ward no. 5 SMC, P.O. Siliguri Bazar, P.S. Siliguri, Distt - Darjeeling, were along with other unknown persons were keeping Alcohol & drinking alcohol, in front of my house at Naharpura noted above, then we told them to go away from here, then they started abusing us in filthy languages & when my brother namely, Sujit Roy (35) S/O Sri Jiten Roy, objected, they started beating us brutally and me and my father, Sri Jiten Roy (65) received severe injury on our persons and they stolen away the silver chain from the neck of my said father.

Sir, me & my father, immediately shifted to Siliguri Distt. Hospital & treated ourselves there.

The above named alleged persons and their unknown associates are very desperate & dangerous in nature & they have threatened us for dire consequences. So, please take necessary action against them.
