Sub:- Complain against a TOTO without Registration Number driven by one Anisur Rahaman roughly and dangerously.

Sir,

Today i.e. on 18.05.2022 around 14:30 hrs one Red Coloured TOTO without any registration number was found to be plying near Panitanki More being driven by one Anisur Rahaman roughly in a dangerous manner. While crossing Panitanki More the driver lost control over his vehicle and the TOTO got capsized by which the 03(three) passengers namely Keshab Das (7319074994), Rekha Mondal (7477843719- Relative of Rekha Mondal) and Sujit Mahali(8597299441) got injured and taken to Siliguri Hospital by the Traffic personnel deployed at Panitanki More for treatment and first aid. The Driver of the said TOTO had violated Government Order by plying unauthorizedly in such busy arterial road and he had a full knowledge that such illegal plying without any authority can lead to a serious Road Traffic accident may lead to loss of life and property. Further it has been learnt that the actual owner of the said TOTO is one Biswajit Neogi of Saradapally of Bhaktinagar P.S.

Therefore sir, I would kindly request you to enquire into the matter and take appropriate legal action in this regard as deemed fit.
