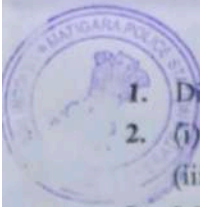

Thereafter I have recorded my respective share of land measuring 0.03 Acre, at the concern BL & LRO, Matigara and a new khatian opened in my name being L.R. Khatian No. 1621, L.R. Plot No. 18 of Mouza Thiknikata, Pargana Patharghata, Police Station Matigara, District Darjeeling.

That thereafter the husband of Smt. Suchandra Ghosh namely- Sri Sanjay Ghosh occupied the land illegally and have been running a business in the name of ASHIYANA DHABA CUM RESTAURANT on the land. Whenever the matter came to my knowledge I raised objection about the illegal act and activities, the said Sri Sanjay Ghosh has threatened me that I am a Police Officer and you cannot do anything against me. Whenever I asked/requested said Sri Sanjay Ghosh to release my land and handover the possession to me, he replied that you have no land and you can take any steps against me nothing will exist against me because I am an Officer of Police and I do not bother or dare of any higher official of me.

Thereafter on 25.01.2021 I have filed a Title (Partition) Suit being No. 19 of 2021 before the Ld. Civil Judge, Senior Division, Siliguri and the said case is pending in the said Court till date and it is to mention here that said Smt. Suchandra Ghosh is not attending in Court on dates.

In this circumstances I am requesting you to look into the matter and take necessary steps so that I can get release of my land which has been illegally encroached by Sri Sanjay Ghosh.
