presently residing at Kadamtala, Embee Fortune  
Kadamtala, Near Durga Mandir of Dist- Doojelling  
wants to bring it to your kind attention that :-

- 1) That on wednesday at around 8.45 pm in the  
night I was returning from my chamber and  
going towards my home, I had to stop at a traffic  
point as the traffic light was red at Nautaghat  
more. And suddenly a white colour pickup which  
is used for carrying goods came from behind and  
hit me from behind. The pick up vanished  
from the above mentioned area even after the concerned  
traffic police tried to stop him. Therefore I could not  
remember the exact vehicle registration number but still  
I noticed the last four digits of the vehicle number  
that was "6310".
