In this regard I SI Khela Murmu of Pradhan Nagar P.S/ SPC, would like to inform you that today i.e. 22.02.2022 while performing exam duty as VLO at Baghajatin Vidyapoth H.S under Pradhan Nagar p.s in c/w final examination of Constable / Lady Constable in West Bengal Police 2020 with ASI Rama Pada Barman (AVLO),PSI Youel Lepcha and C/830-Pradeep Roy, C/1419-Ashis Roy, C/1119-Tanmoy Roy, C/1414 Dilip Barman vide PDN PS LOCC/ No. 253/22 dated. 22/05/2022 .During frisking and Checking at the Main entrance gate of Examination centre at that time I noticed that one candidate namely Suraj Kumar s/o Kampu Mondal of Halimpur Jamalpur ,PS Nayaram Nagar, Dist Mungar ,Bihar turned up before me and produced one pan card bearing No CTRB1608M and copy of admit card in the name of Bablu Biswas S/O Biswanath Biswas of Sajerpara Ghoramara ,PO-S.P Ghoramara ,PS Pundibari, Dist Coochbehar. On verifying signature and face of the candidate does not resemble with the original Admit card. On being asked he made incoherent statements and finally he admitted that said Suraj Kumar s/o Kampu Mondal of Halimpur Jamalpur ,PS Narayam Nagar,Dist Mungar,Bihar turned up the examination centre impersonating himself as Bablu Biswas in lieu of money.
