Respected Sir,

This is to inform you I, Bhanwarlal Rathi, aged about 81 years, Son of Late Prabhudayal Rathi, permanent resident of Rathi Bhawan, Dr. Kalinath Road, Naya Bazar, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, West Bengal, PIN - 734005. That out of family settlement between my brothers a verbal partition was made with regard to our residential premises comprising of a three storied pucca building standing on a piece and parcel of land measuring 0.0325 Acre, situated in R.S. Khatian No.5706. corresponding to L.R. Khatian No.2458, R.S. Plot No.7511, corresponding to L.R. Plot No.3100, J.L. No.88. Mouza - Siliguri Madhya, J.L. No.88, P.S. Siliguri, Dist. Darjeeling, situated at Dr. Kalinath Road, Naya Bazar, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, West Bengal, PIN - 734005, I was given the share to possess and reside till my lifetime in the Southern side of the first floor of the abovementioned residential premises and in my said share I was provided one room, one kitchen, one balcony (facing Dr. Kalinath Road, Khalpara) and one store room; the toilet, staircase and passage was allowed on the terms of common usage, and in the said residential share I have been residing with my wife Santosh Devi Rathi, aged about 73 years, since the year 1966. That presently the aforesaid kitchen was / is in dilapidated condition and there was every chance of its damage which could cause harm to life and property, and thus I had engaged some labourers for repair of the said kitchen. That few days after the initiation of the said repair work of the kitchen my elder brother Dhanpath Ray Rathi and his younger son Pawan Kumar Rathi suddenly to my utmost shock forced us to stop the repair work of the kitchen and further asked us to leave our residential premises in which we have been residing and enjoying our every right since 1966. That when I protested to such act of my elder brother Dhanpath Ray Rathi, the said Pawan Kumar Rathi verbally abused me in a threatening voice and language and further threatened us if we did not vacate our said residential premises immediately. It is pertinent to mention here that I am an aged person, 81 years old, residing alone with my wife in the aforesaid premises since 1966 and I have every right over the said residential premises. Now looking into the past records of Pawan Kumar Rathi, he has been involved in physical assault of other parties and I therefore feel threatened and insecure. Therefore would like

intervention of relevant Government Authorities as I feel my life is in threatened, I plead and seek protection of mine and my spouse's life because I am under great trauma and threat due to the acts and behaviour of my elder brother Dhanpath Ray Rathi and his younger son Pawan Kumar Rathi. So far I alongwith my old aged wife am passing days with utmost distress and difficulty and insecurity, it is pertinent to mention here that the kitchen work has been stopped midway and we are not having basic access to even food and water.

Hence, it is prayed before goodself to kindly look into the abovementioned matter and take necessary action against the said Dhanpath Ray Rathi and his younger son Pawan Kumar Rathi as per the due course of Law and also if your goodself could provide us security so that the kitchen work can be completed as otherwise it is very difficult for us to sustain without food and water.
