Sir,

In producing herewith one arrested accused person namely Buddha Gurung (M/58) S/O- Lt Bahadur Gurung of Bagrakote, Near F.C.I Godawn, Ward No. 20, PS- Siliguri, Dist- Darjeeling also seized articles (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized article No- (i).

I, ASI Ratan Kr Ghosh of Panitanki TOP under Siliguri PS do hereby lodge a written complaint against the above noted accused person to the effect that today on 21/05/2022 at 08:15 hrs during mobile van patrol I received secret source information that, one person is selling huge quantity of country spirit at Bidhan road near Gosto Paul More, under Panitanki TOP. Accordingly I informed the information to OC Panitanki TOP. As per his direction I along with ASI Gazi Rahaman, C/114 Naresh Hasda, and CV-1007 Jiten Roy left for work out the information. On arrival at Bidhan road near Gosto Paul More at 08:25 hrs being pointed out the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon Bag. I intercepted the said accused person with loaded articles in presence of witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the articles to the local people of Bagrakote adjacent area illegally with a view to earn huge money for his lively hood. I also intercepted the said person with loaded articles in presence of witnesses. On search I found (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SI. No.

On interrogation he failed to produce any valid documents/license in support of the same and stated that he will sale the same to the local people illegally with a view to earn huge money for his lively hood. Accordingly I seized (i) 10 (Ten) Bottles of 60 UP Country Spirit styled as HIMALAYAN GOLD measuring 600 ml each when packed, MRP Rs. 120/- each (ii) 01 (One) Nylon Bag which used for carrying the seized article (i) under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also arrested the accused person and arrested him. The seizure was made between 08:45 hrs to 09:15 hrs and arrested the person u/s 41 Cr. P.C after explaining charge against him. Total value of seized articles is Rs. 1200/-

Under the above circumstances I am submitting this written complaint against the above accused person namely Buddha Gurung (M/58) S/O- Lt. Dhanbahadur Gurung of Bagrakote, Near F.C.I Godawn, Ward No. 20, PS- Siliguri, Dist- Darjeeling for starting a specific case under proper section of Law and to arrange investigation.
