I, Smt. Anila Gope Das, wife of Sri Biplab Das, R/o. Vivekanandapally, P.O. & P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, presently residing at Village Abhiramjote, P.O. Tarbandha, P.S. Bagdogra, District Darjeeling, Pin-734014, West Bengal, would like to state that on hearing about ill health condition of my sister-in-laws father-in-law my husband on 20.05.2022 at about 5.30 P.M. went to see him at his residence at Naukaghat More, District Darjeeling. As there was no vehicle at my home so he took the Tata Magic alone in hurry. After filling diesel from Bharat Petrol Pump, near Medical Old Gate, when my husband turned his vehicle towards main road of Naukaghat More with his Tata Magic being No. WB 76 9790 suddenly a Shaktiman Truck bearing WB 73 4247 hit my husband's Tata Magic on right side. Due to the said accident my husband sustained serious injuries and was admitted to North Bengal Medical College & Hospital, Sushrutanagar, Matigara. Later for better treatment I with my family members help admitted my husband at Neotia Getwell Health Care Centre, Matigara. The Doctors admitted him at ICU and he is still at ICU. The vehicle has also been fully damaged. Later I came to know that the name of the owner of the Shaktiman Truck is Ghanshyam Singha, son of Late Biswanath Singha, R/o. Village Pharanijote, P.O. Ranidanga, P.S. Bagdogra, District Darjeeling, Pin-734014. The Shaktiman Truck was overloaded with river sand & stone. The driver of Shaktiman Truck ran away from the accident spot. I was late in lodging the FIR due to serious condition of my husband.

It is requested before you to do the needful and take strict necessary action against the culprits involved in the said accident so that he can be punished as per law for his illegal act.
