In producing herewith eight (08) arrested accused persons namely (1) MD. Chattu(29) S/O- Late MD. Amiruddin of Dangpara , Bucharpotty W/No- 6 P.S- Siliguri , Dist- Darjeeling , (2) MD. Saddam (21) S/O-Late MD. Alauddin of Kailadepot P.S- Siliguri Dist- Darjeeling ,(3) Bigen Tamang (25) S/O- Tshring Tamang, Mapaitaya P.S- Kalimpong Dist- Kalimpong, (4) Dulay Roy @ Mohoranjan (23) S/O- Khogen Roy of Samarnagar Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri ,(5) Susankar Paul @ Rintu (19) S/O- Late Sushil Roy of Uttar Samarnagar , Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri, (6) Manik Barman(20) S/O- Bidhan Barman of Uttar Samarnagar , Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri,(7) Chogyal Lepcha(24) S/O- late Ugen Lepcha Rabangla P.S.- Rabangla Bazar, South Sikkim and (8) Sajal Rai (19) S/O- Late Rupan Rai of Chhota Fapri P.S- Bhaktinagar Dist- Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made Hasua having wooden butt measuring 24 inches (approx) in length from the possession of MD. Chattu which was kept on his right hand,
- (2) One iron rod measuring 40 inches (approx) in length from the possession of MD. Saddam which was kept on his right hand,
- (3) One iron made 'Hammer' measuring 10 X 4 X 4 cm (approx) having bamboo handle measuring approx 32 cm in length from the possession of Bigen Tamang which was kept concealed on his back side,
- (4) One Iron rod measuring 40 inches (approx) in length from the possession of Dulay Roy @ Mohoranjan which was kept on his right hand,
- (5) One Iron rod measuring 30 inches (approx) in length from the possession of Susankar Paul @ Rintu which was kept on his right hand.
- (6) One iron made Hasua having wooden butt measuring 24 inches (approx) in length from the possession of Manik Barman which was kept on his right hand,
- (7) One Iron made chisel measuring 22 inches from the possession of Chogyal Lepcha which was kept on his right hand.
- (8) One torch light from the possession of Sajal Rai which was kept on his right hand.

I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (1) MD. Chattu(29) , (2) MD. Saddam (21) ,(3) Bigen Tamang (25), (4) Dulay Roy @ Mohoranjan (23) (5) Susankar Paul @ Rintu (19) (6) Manik Barman(20) (7) Chogyal Lepcha(24) and (8) Sajal Rai (19) and others to the effect that today on 23.05.2022 at 00.05 hrs received a sources information that 12/14 youths have assembled near Dagapur Tea Garden under Pradhannagar P.S with a view to commit dacoity at Darjeeling more area. The fact was diarized in GDE vide Pradhannagar PS GDE No-1459 dated 23.05.2022. Subsequently, I shared the information with I/C Pradhannagar P.S. and as per his direction, I along with ASI Tarun Kanti Ghosh C/762 Mojibul Rahaman , CV-645 Pankaj Gupta , CV-223 Swapan Chettri , CV-992 Jagadish Biswas, CV-646 Babun Das, CV-128 128 Ajoy Sahani and CV-242 Rakesh Manger left for the place to work out the information.

At about 00.45 hrs after reaching Near Dagapur Tea Garden under Pradhannagar P.S. I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot in multi direction. But, on hot chase we managed to apprehend above noted eight (8) accused persons namely (1) MD. Chattu(29) , (2) MD. Saddam (21) ,(3) Bigen Tamang (25), (4) Dulay Roy @ Mohoranjan (23) (5) Susankar Paul @ Rintu (19) (6) Manik Barman(20) (7) Chogyal Lepcha(24) and (8) Sajal Rai (19) along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Darjeeling more area . It is also revealed from them that (1) MD. Chattu(29) , (2) MD. Saddam (21) ,(3) Bigen Tamang and some others have assembled there with them and planned for committing the dacoity.

I thereafter, seized the above noted weapons under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole seizure was made in between 01.20 hrs. to 01.55 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Pradhannagar Police Station for further investigation.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons namely (1) MD. Chattu(29) S/O- Late MD. Amiruddin of Danglipara , Bucharpotty W/No- 6 P.S- Siliguri , Dist- Darjeeling , (2) MD. Saddam (21) S/O-Late MD. Alauddin of Kailadepot P.S- Siliguri Dist- Darjeeling ,(3) Bigen Tamang (25) S/O- Tshring Tamang Mapaitaya P.S- Kalimpong Dist- Kalimpong, (4) Dulab Roy @ Mohoranjan (23) S/O- Khogen Roy of Samarnagar Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri ,(5) Susankar Paul @ Rintu (19) S/O- Late Sushil Roy of Uttar Samarnagar , Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri, (6) Manik Barman(20) S/O- Bidhan Barman of Uttar Samarnagar , Bowbazar P.S- Bhaktinagar Dist- Jalpaiguri,(7) Chogyal Lepcha(24) S/O- late Ugen Lepcha Rabangla P.S.- Rabangla Bazar, South Sikkim and (8) Sajab Rai (19) S/O- Late Ruppan Rai of Chhota Fapri P.S- Bhaktinagar, Dist- Jalpaiguri and others and arrange for its investigation.
