SUBJECT: REQUEST TO PROTECT FROM LAND MAFIA

Sir

With due regard and humble submission I, Smt. Pasang Lama (Sherpa), Wife of late Wangdi Lama, aged about 83 years, resident of Salugara Bazar, Ward No-42(SMC), P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri, do hereby submit the following for your kind persual and necessary action :-

1. That I belong to a Scheduled Tribe community and presently I am the owner of the total land measuring about 10 katha and out of which 7 katha is recorded in Plot No- 77/233, Sheet No-3, Khatian No- 81(HAL) Mouza- Dabgram and the remaining land 3 katha is recorded in Khatian No- 2045, Plot No- 33/1(Hal) Sheet No-3, Plot No- 39/231, Mouza- Dabgram Sheet No-3, P.S- Bhaktinagar, under Ward No- 42 (SMC) Dist- Jalpaiguri.
2. That I and my husband purchased the said land in the name of Dawa Lama who was our son who died on 05-03-2011 leaving behind him his wife Smt. Kali Lama who also died on 9-05-14 and myself as the only legal heirs to inherit the properties left behind them.
3. That I constructed a house upon the said land to Dawa Lama along with some shops situated at Debi Chaudharani Road, East Salugara, Ward No-42 (SMC), P.S- Bhaktinagar, Dist- Jalpaiguri, as fully described in the Schedule below for the livings and in order to pull his life.
4. That after the death of my daughter in law namely Kaali Lama, I became the absolute owner of the said land as there is no any other legal heirs of Dawa Lama & Kali Lama except me.
5. That after the death of my son & daughter in law, some antisocial elements of that area namely 1. Smt. Sakuntala Rai and land Mafia Gang resident of Debi Chaudharani Road, East Salugara, Ward No-42 (SMC), P.S- Bhaktinagar, Dist- Jalpaiguri are trying to encroach/grab my said land illegally for their ill motive and they have also obtained some documents by adopting illegal means fraudulently & dishonestly with the help of some antisocial elements.
6. That the above named persons are trying to take forcible possession of my said Property by illegally & unlawfully manner and said Sakuntla Rai does not belong to Tribal Community and she is a fraud lady and belong to Land Mafia gang who by obtaining illegal means prepare documents and capture /grab land of innocent people for her ill motive.
7. That the above named persons are threatening me and my other family members and also showing their muscle power in order to grab forcible my said property for their illegal benefit and ill motive and also trying to wrongfully dispossess me and my other family members from my land and trying to involve me and my family members in a fake case.
8. That earlier I had reported the matter to the Bhaktinagar P.S but no action was taken against them till date as they are very powerful person.
9. That Smt. Sakuntala Rai is the financer and belongs land Mafia Gang and she can do anything to grab/occupy my land.
10. That the above named person are very dangerous and in character and can do everything/ murder in order to grab my said land and with fear I am unable to go towards my said land as they might kill me any other family members.
