

Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do hereby lodge this complaint against Sri. Ram Bahadur Darjee (ph no- 7063107751), S/O Not Known, resident of Betgara-1, Nr.K.B. Gurung House, Po-Salugara, P S Bhaktinagar, Dist Jalpaiguri, West Bengal. While on a routine inspection on the site having consumer id 400859845, meter no IPB258587, today on 23.05.2022 at around 1.30pm, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with other technical staffs observed that the house of Sri Ram Bahadur Darjee has been extended in an un authorized manner hampering the safety clearance of the electrical installations of WBSEDCL. As per Indian Electricity Rules 1956, 80 (1) (a) a minimum vertical clearance of 3.7 meters & under 80 (2)(a) a minimum horizontal clearance of 1.2 meter was to be maintained between any part of the building and the Low And Medium Voltage Lines and networks of WBSEDCL. But the un authorized extension of the building has resulted to the Low Tension All Bundle Cables to touch the building, thus violating the standards as per Indian Electricity Rules 1956, 80 (1) (a) & (2)(a). This violation shall cause terrible outcomes in respect to safety hazards that will result in accidents, which might be fatal in nature. Thus you are requested to kindly initiate an investigation against Sri. Ram Bahadur Darjee, by treating this as F.I.R. This is for your information and necessary action please.
