In producing herewith one person namely Biplob Das @ Bapi (26yrs) S/O Lt. Biswanath Das of Putimari PS Bagdogra Dist. Darjeeling along with the following articles under seizure viz,

1. 20 bottles of Himalayan gold 60 up country sprit (each bottle containing 600 ML) Marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 01 (One) Plastic Container of Local handmade "CHOLAI" (containing 5 litter) Marked as Exhibit "B" from which 01 litter randomly taken out as sample and marked as Exhibit "B-1",
3. 01 (One) Plastic Container of Local handmade "CHOLAI" (containing 5 litter) Marked as Exhibit "C" from which 01 litter randomly taken out as sample and marked as Exhibit "C-1",
4. 01 (One) Plastic Container of Local handmade "CHOLAI" (containing 5 litter) Marked as Exhibit "D" from which 01 litter randomly taken out as sample and marked as Exhibit "D-1",
5. 01 (One) Plastic Container of Local handmade "CHOLAI" (containing 5 litter) Marked as Exhibit "E" from which 01 litter randomly taken out as sample and marked as Exhibit "E-1",

I, ASI Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this written complaint against the above noted arrested person namely Biplob Das @ Bapi (26) S/O Lt. Biswanath Das of Putimari PS Bagdogra Dist. Darjeeling to the effect that on 20.05.22 in course of Night special mobile duty along with force under Bagdogra PS, area vide GDE no 1017 Dtd, 20.05.22 at around 23.05 hrs received a secret source information that one person is selling huge quantity of illicit liquor at Bagdogra Putimari area to his designated customers and as per your kind instruction, I along with force rushed at Bagdogra Putimari village area to verify the veracity of information. At around 23.25 hrs we reached at Bagdogra Putimari village area parked the vehicle in a considerable distance and approaching towards Putimari village source point out one house in a distance we cordon the house without styled seeing the police team he tried to flee away a hot chase police party managed to apprehended the above noted arrested person who is selling illicit liquors some of his designated customers clandestinely presence of police team some customers who were gathered for purchased liquor on his house were flee away to run from the spot. Accordingly, I search independent witness to remain present during search and seizure but none shown on the spot. On interrogation Biplob Das @ Bapi admitted that he is the owner of house and run the illicit liquor selling business since long time for his wrongful gain on demand he failed to produce any valid documents or license on support of storing and selling the said huge quantity of illicit liquor recovered from his house. Accordingly, I seized and labelled the above mentioned illicit liquor recovered on his house under proper seizure list in presence of police witness and arrested him u/s 41 CrPC issuing memo of arrest and inform his ground of arrest. The whole process of seizure and labelled was made in between 23.35 hrs to 00.05 hrs. Total 32 ltrs illicit liquors.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against above noted accused Biplob Das @ Bapi (26yrs) S/O Lt. Biswanath Das of Putimari PS Bagdogra Dist. Darjeeling and arrange for its investigation.
