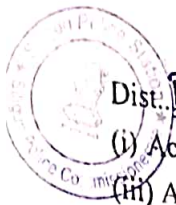

Respected Sir,

I am Indranil Chakraborty from Palashbari T.G. Banarhat, Jalpaiguri. Presently I reside at Hakimpara Ward No 15, Siliguri at my Uncle house for job purpose in Siliguri. On 9<sup>th</sup> May 2022 I saw a Job Advertisement on Uttarbanga Sambad Newspaper and I contacted that given number. First person name Sayan Banerjee (Ph No. 8512918501) told me there is Bandhan Bank Vacancy and asked for payment of Rs. 300/- as application fee I paid them through online transaction ( Google Pay UPI). After that they gave a application form and I filled that and send to them through Whatsapp. Then second person name Apurba Roy (Ph No. 8145622719) called me and asked me for a payment of Rs. 2500/- as for ID Card and Salary Account fee and I paid it through online transaction (Google Pay UPI). After that Apurba Roy again called me and asked me for a payment of Rs. 7200 for joining letter and told me they will refund my all money after joining. I again paid that said amount through online transaction. Later that they give me a joining letter but not mentioned which branch I will go for joining. I called them and asked them and again they asked me for a payment of Rs. 22,000/- which I can't afford so I told them and asked them for refund my all money but they refused to do so. I called them severally and also contact another person who is member of them (Ph. No. 8303516542 and I do not know his name) but they refused to refund me everytime.

Therefore, I want to lodge a FIR on them and request you to please accept my application and take a step on them and give my money refund to me.

All payments are done through my cousin brother Google UPI account and all related documents enclosed with this application.
