Me & said Kanhaiya Prasad, received severe injury on our persons and immediately shifted at Siliguri Distt. Hospital, & treated us there, they have stolen away the gold chain of Kanhaiya Prasad & Rs. 3000/- from me. So, please take necessary action against above named alleged persons namely (1) Bablu Gupta (2) Arjun Gupta (3) Bholu Gupta all son of Sri Bijay Gupta (All are resident of Maharaj Colony (Behind Vishal Mega Mart) Ward No. 4 SMC, P.O & P.S-Siliguri, Distt-Darjeeling, and (4) Dabba Gupta S/O Not known & (5) Bablu Gupta S/O Sri Pannalal Kaner, both are resident of S.P. Mukherjee Road, Near Suba Bhawan, Ward No. 9 SMC, P.O & P.S-Siliguri, Distt-Darjeeling, because they may come again and may physically assault us.
