I, Smt. Payel Sarkar (Saha), W/o Sri Pintu Sarkar, at present residing at C/o Gour Saha of Samar Nagar, Shimulguri, P.S. Bhaktinagar, Dist. Jalpaiguri, beg to inform you that my marriage with my husband Pintu Sarkar, S/o Dilip Sarkar of Kubharpur, Baghan, P.O. & P.s. Kaliaganj, Dist. Uttar Dinajpur was held on 09-08-2015 at a marriage 24.15 2012 bhawan namely "Parinita", Mohanbati, P.O. & P.S. Raiganj, Dist. Uttar Dinajpur, according to Hindu rights and customs of Hindu Marriage Act in presence of guests and relatives of both sides. Before marriage on the vicle GDG demand of my-in-laws so many gifts like golden ornaments, furniture, beddings, wearing apparels including cash of Rs.40,000/- were given by my parents despite their poor economic condition however following the He ruffrage the next day I was taken my matrimonial home where my husband my parents-in-law Sri Dilip Sarkar, Smt. Shyamali Sarkar also there besides them, my one married sister-in-law Pinki Das, Smt. Poly Ghosh aunty-in-law (Masi Sasuri) who use to visit their very off and on. Since marriage for about a year I lived there more or less peacefully Bhoth hing malthough they use to abuse me for insufficient dowry according to their demand including cash and gold ornaments. For the sake of peace of my matrimonial life my father within a year again gave one golden necklace No 553/22 and one golden chain for my husband yet for the demand of more cash at least Rs.1,00,000/- they could not be satisfied and started to threaten (Ad. 24/5/22 me under pressure 1 having no alternative tolerated everything. Significantly the income of my husband was also not good which they falsely disclosed to us at the time of marriage so also of his qualification 492 A 44 falsified before the marriage to us. For all the reasons I was only to be M & Sec blamed by all the above named in-laws including my husband. However on 16-08-2018 a female child namely Tanishka Sarkar born to us and for giving birth of a female child all of them became angry and blamed me for that reason also. Although my parents extended their help at their level best capacity in sending money and sometimes giving wearing apparels food items etc. but that could not pacify them. My husband is a habitual drunker and also a gambler so wasting money for that whatever his earning. He was an employee of a plywood mill and at present selling chicken for customers. Gradually my husband started to behave with me Sign Price Commerce 8th

In a rude and violent manner even for many times mercilessly assaulted me physically beside mental torture in presence of other above named in laws who all supportd him and abused me hurling slang language not only against me but my parents too. On 23-06-2020 evening hours my husband and other in laws started to abuse me for no reason whatsoever blaming me to be a destitute woman and my husband all on a sudden assaulted me telling that I must leave the matrimonial house as they do not like me and my family and the female child at all and I was seriously ill throughout the night and my parents on the following day on 24-06-2020 took me back to our house with my minor child. However after prolonged request and negotiations I was again brought to my matrimonial home by my parents on 20-11-2020 but unfortunately then again on 21-11-2020 they started to misbehave with me and torture me both physically and mentally so unable to withstand this torture I with my minor child during the morning hours on 23-11-2020 went out from the matrimonial home and took shelter at the residence of my grandfather namely Amal Hore, at Raiganj, Kharmujaghat, New Milan Para from where my father took me back to them at my parents place. Since then I am living here but they on repeated occasions threatened me over phone. My husband also threatened me to kill me in any opportune moment or at any time. My husband and including the above named in laws by their repeated cruel acts made my life hell and so I am apprehending danger at any moment of my life as well as life of my minor child.

Accordingly I pray to you to investigate the case against my husband and in laws for the offences committed by them.
