I, Smt Prabha Tewari, 40/1mg, w/o Vishal Tewari,
s/o Lt Dilip Tewari, resident of Bhanu Nagar, 2nd Mile
Near Hotel Alishan, P.O. Sevoke Road, P.S. Bhaktinagar, Dist.
Jalpaiguri humbly submit the following:

1. That my marriage with abovenamed husband was solemnized on 9-03-2009 at ~~head~~ my residence at Pradhan Nagar, as per Hindu Rites & Customs.
2. That out of the wedlock one male child has been born to me on 02-10-2015 who is now 6 years old and studying in Class 2 in Don Bosco School, Siliguri.
3. That after our marriage since few months my husband started inhuman cruelty, torture and indiscriminate physical assault with fists, kicks and dandas whatsoever and has been torturing me in front of his family members each and everytime. I have been tolerating all ~~to~~ such inhuman torture for the sake of my son but he is now violent and is always attempting to kill me, ~~and~~ without any reason or fault on my part.
4. That yesterday on 25-5-2022 at about 10:30pm suddenly he started hitting me with fists, kicks and dandas inhumanly. He made me nude and unable to run away being naked and in such condition he started strangling me grabbing with his two hands and ultimately he brought a iron hammer and blew it towards my head but however I ~~managed~~ was rescued and saved

by the neighbours who heard my screaming and weeping and crying.


5. That it is the fact that as and when he gets any more opportunity he will surely kill me either by strangling or by burning or by hanging with rope.

6. That in such condition I am fearing serious danger to my life in his hands at any moment.

I therefore kindly pray your good self to take prompt legal actions against him and save my life.
