Sub: First Information Report

Dear Sir,

With due respect, I would like to lay following few lines for favour of your kind consideration and necessary action:

That I am an old aged and sick lady aged about 82 years and living at my house situated at Rani Sati Road, Ganga Nagar, P.O. Siliguri, District Darjeeling.

That my sons namely; Sri Pawan Joshi, Sri Devanand Joshi and Sri Rajesh Joshi are taking care and looking after me in all respects after the death of my husband as my son Sri Dinesh Joshi is employed in a Tea Garden in Assam and lives with his family.

That the marriage of my son Sri Dinesh Joshi was solemnized with Smt. Nidhi Joshi at Darbhanga (Bihar) on 19/01/2006 as per Hindu rites and customs i.e. before more than about 16 years.

That my two sons namely; Sri Pawan Joshi and Sri Devanand Joshi are unmarried and living with me.

That my son Sri Pawan Joshi became seriously ill and was admitted in Pragati Nursing Home situated at Bye-pass Road under Bhaktinagar Police Station for treatment on 20/11/2021 but for the want of better treatment he was shifted to Anandlok Nursing Home, Siliguri on 22/11/2021 where he was under treatment for about one month and his thumb of right hand was amputated there.

That when my said son Sri Pawan Joshi was under treatment in Anandlok Nursing Home my son Sri Dinesh Joshi, his wife Smt. Nidhi Joshi, Sri Vivek Sharma @ Guddu (brother of Smt. Nidhi Joshi) and two other persons visited my house and started to abuse me with filthy languages, slapped me and demanded money from me under threatening of my life but I could be saved by the neighbours.

That my son Sri Pawan Joshi had to rush to Chennai for treatment and he got himself admitted in Apollo Hospital, Chennai on 03/04/2022 and there also he was operated seven times and discharged on 11/04/2022 but as he is still suffering from various ailments he again went to Bengaluru from Chennai on 03/05/2022 and is still under treatment there but my son Sri Dinesh Joshi never visited him nor paid a single farthing for his help.

That after marriage my son Sri Dinesh Joshi and his wife Smt. Nidhi Joshi never lived with me but about 5 – 6 months ago Smt. Nidhi Joshi visited Siliguri with her children, namely; Parth Joshi and Diksha Joshi and forcefully started to live at my house situated at my aforesaid address.

That from the day of reaching Siliguri Smt. Nidhi Joshi started to pick up quarrel with me and my youngest son Rajesh Joshi, his wife Smt. Bipasha Joshi and other family members without any cause and sometimes she used filthy languages against me.

That my daughter-in-law Smt. Nidhi Joshi also started threatening me and asking me to register my house in her name otherwise she shall put me and my son Sri Rajesh Joshi and his wife Smt. Bipasha Joshi in trouble by lodging false complaints to Police Station, Mahila Samity and Ward Councilor.

That Yesterday evening, she again asked me to give my all landed properties and my ornaments to her and when I refused to do so she, with the help of her minor children, tried to assault me but I could be saved by the grace of God.


That I came to learn that Smt. Nidhi Joshi has lodged a false Complaint with Siliguri (W) Police Station on 12/05/2022 against my son Sri Rajesh Joshi and his wife Smt. Bipasha Joshi and a Siliguri (W) P.S. Case No. 74/2022 under Section 498A read with Section 4 of DP Act has been started against my younger sons.

That Smt. Nidhi Joshi may also lodge a false complaint against me and as such I apprehend danger to my prestige, life and properties.

Therefore, I request you to kindly accept this First Information Report and to do the needful as per provisions of Law and oblige.
