Sir,

In producing herewith five(05) arrested accused persons namely (i) Bino Sahani(22yrs) S/o- Late Dayal Sahani of Tikiapara, Hatath Colony W/no- 28, PS- Siliguri Dist- Darjeeling (ii) Sambhu Roy @ Chokfula(30yrs) S/o- Late Suren Roy of Siliguri Town Station PS- Siliguri, Dist- Darjeeling (iii) Subir Sarkar @ Bocha(48yrs) S/o- Late An Chandra Sarkar of Uttar Bharat Nagar, PS- Siliguri, Dist- Darjeeling (iv) Md. Ali(38yrs) S/c Late Md. Jashim of Jhankarmore, Jyotinagar, W/no- 04, PS- Siliguri, Dist- Darjeeling, (v) Biki Sahani(22yrs) S/o- Late Kapil Sahani of Hatath Colony W/no- 28, PS- Siliguri, Dist Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made 'Katari' measuring 24 inch (approx) including wooden butt from the possession of Binod Sahani which was kept concealed on his back side,
- (2) One iron made sword measuring 35 inch (approx) including wooden handle from the possession of Sambhu Roy which was kept concealed on his back side,
- (3) One Iron rod measuring 40 inch (approx) in length from the possession of Subir Sarkar which was kept on his right hand,
- (4) One iron made sword measuring 30 inch (approx) including wooden butt from the possession of Md. Ali which was kept concealed on his back side,
- (5) One iron made Crowbar measuring 36 inch (approx) in length from the possession of Biki Sahani which was kept on his right hand,

I, PSI- Sumit Rawat, S/O- Puran Rawat of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Bino Sahani, (ii) Sambhu Roy (iii) Subir Sarkar (iv) Md. Ali, (v) Biki Sahani and others namely M Bappa, Lengra, Poltu and others to the effect that today on 24.05.2022 at 00.15 hrs receive a source's information that 10/12 youths have assembled at Mahananda River Bed near Santoshi Nagar under Siliguri PS with a view to commit dacoity at Santoshi Nagar. The fact was diaryed in GD vide Siliguri PS GDE No- 1385 dated 24.05.2022. Subsequently, I share the information with I/C Siliguri PS and as per his kind direction, I along with ASI Rabi Lama, ASI Sibin Sarkar, ASI Amar Raj Subba, Sarkar C/1403 Sumit Roy, CV/283 Prasanta Dey and CV/622 Ramanath Barman left for the place to work out the information. At about 01.05 hrs after reaching Mahananda River Bed side, near Santoshi Nagar under Siliguri PS met my source and as pointed by the source we started walking towards River Bed. At 01.2 hrs we reached there and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot. After seeing police personnel approaching towards them they tried to flee away but on hot chase we managed to apprehend the above noted five(05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Santoshi Nagar.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Santoshi Nagar. It is also revealed from them that Md Bappa, Lengra, Poltu and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Binod Sahani(22yrs) S/o- Late Dayal Sahani of Tikiapara, Hatath Colony W/no- 28, PS- Siliguri, Dist- Darjeeling (ii) Sambhu Roy @ Chokfula(30yrs) S/o- Late Suren Roy of Siliguri Town Station PS- Siliguri, Dist- Darjeeling (iii) Subir Sarkar @ Bocha(48yrs) S/o- Late Anil Chandra Sarkar of Uttar Bharat Nagar, PS- Siliguri, Dist- Darjeeling (iv) Md. Ali(38yrs) S/o- Late Md. Jashim of Jhankarmore, Jyotinagar, W/no- 04, PS- Siliguri, Dist- Darjeeling, (v) Biki Sahani(22yrs) S/o- Late Kapil Sahani of Hatath Colony W/no- 28, PS- Siliguri, Dist- Darjeeling and (vi) Md Bappa, ,(vii) Lengra, ,(viii) Poltu and some others and arrange for its investigation.
