Sir, With due respect I Kopin Deb Barman son of Chandrakanta Barman resident of Shanti Nagar, Boubazar, Laxminarayan Kali Manda, PS. Bunkalinagar, Dist. Jalpaiguri would like to inform you that I am a Toto driver and I ply Toto mainly from Siliguri Court more to Awrobinda Pally. Unfortunately for last few days one person namely Ratan Das S/O Tanuz Das resident of Subhaspally Liche bagan, Ward no 18 of S.M.C. P.O. PS. Seliguri, District - Darjeeling along with an other 4, 5 persons have been threatening me and other Toto drivers by saying that if we want to ply Toto at Court more then we will have to pay him 'Hapta' (money) otherwise he and his gang will not allow anybody to ply Toto at Court more. Today at about 8 p.m. he <sup>along with 4 persons</sup> came to Court more and demanded money from me and other toto drivers and when we refused to pay any money he became furious and he and his partners started beating me and showed a pistol and bhojoli and I snatched Rs. 14,700 from me and threatened me and other drivers that if we file any complaint to police then he will come again and kill us. He further told that he will come every day to collect 'Hapta' from Toto drivers and if we don't pay 'Hapta' to him he will not allow any body to ply toto at Court more.
