Dear Sir,

With due respect I, SRI GAUTAM GHOSH, S/O Late Narayan Chandra Ghosh, residing at Balai Das Chatterjee Road, Hakimpara, Siliguri, P.O.& P.S. Siliguri, Dist- Darjeeling, would like to lodge this written complaint to the effect that my friend namely SRI PRASENJIT GHOSH, resident of Girish Ghosh Sarani, Hakimpara, Siliguri, Dist. Darjeeling, has been constructing his dwelling house on his own land and one supplier namely SARBASISH GHOSH (BETUA), resident of Balai Das Chatterjee Road, near Arunaday Sangha, Hakimpara, Siliguri, P.O.& P.S. Siliguri, Dist. Darjeeling, has approached my said friend that he will supply the construction materials like sand and bajri and since the month of February, 2022 he has been supplying the same in the house of my said friend. On 21.05.2022, said Sarbasish Ghosh has delivered low quality sand of one Truck (TATA) to the working site of my said friend and after seeing such type of low quality sand, my friend called me and asked me about the quality of said sand and I answered that the sand is not too good and ultimately, my said friend has protested and made complaint to the said supplier and requested him not to deliver such type of low quality materials to him.

Sir, I further beg to inform you that on 22.05.2022 at about 11 P.M, said SARBASISH GHOSH (BETUA) along with his associates, came to the house of my said friend and has broken the lock of the main gate and forcefully trespassed into the working site of my said friend and also started to through abusive and filthy languages in the name of my said friend and also in my name before the caretaker of said friend and he has also damaged some construction materials in the working site. Thereafter, he ranged me and started to abuse me with filthy and offensive languages over mobile phone and he also threatened me with dire consequences by saying that he will cause irreparable loss to me but at that time, I have requested him to go to his house as he was in drunken condition and subsequently, he left the place.

Sir, today at about 6.00 P.M., said SARBASISH GHOSH (BETUA), along with his associates, came with drunken condition, along with some deadly and sharp cutting weapons, in the shop room of my younger brother SRI PINTU GHOSH, situated at Balai Das Chatterjee Road, near Paulpara Friends Union Club, Hakimpara (Paulpara), Siliguri, and started to threatened my brother SRI PINTU GHOSH to close the shop room immediately, otherwise, he will destroy the materials and when my brother raised his objection against such type of illegal activities of said SARBASISH GHOSH (BETUA) and his associates, they became furious and started to assault my said brother with the help of deadly and sharp cutting weapons and seeing such situation, when my elder brother SRI UTTAM GHOSH tried to rescue him from their clutches, they have assaulted my elder brother also and when they starting shouting for help, the miscreants above named, left the place and at the time of leaving the spot, they have snatched a sum of Rs.5000/- cash from the cash box of my younger brother's shop. They have also threatened my brothers that if they inform the aforesaid matter before any authority, they will not hesitate to ruin their live and property.

I, therefore, request you to kindly take necessary legal steps against the aforesaid persons/ culprits in accordance with law.
