This is to inform you that an absconding vehicle has broken one no. of PCC Electric Pole early morning on 24th Jan, 2022 near Milanpally More, Mukanda Das Road. This has resulted in the damage of PCC Pole, Iron fitting, insulators and ACSR conductors. Massive power interruption has occurred resulting in grievance of common people. The Total Damage incurred was Rs. 26,487 /- only (Twenty six thousand four hundred and eighty seven only).

You are therefore requested to treat this as an FIR in the interest of common people.
