In producing herewith the 04 (four) arrested accused persons namely (1) Shankar Shil (40 yrs) S/O - Lt. Bhanu Shil of Madhya Shantinagar near Pipe Line, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Gour Kundu (38 yrs) S/O- Sasthi Kundu, C/O- Raju Das of Purba Chyanpara near Kali Saha More, Ward No 37, PS- Bhaktinagar, Dist- Jalpaiguri, (3) Biplab Majumder (40 yrs) S/O- Lt. Birendra Nath Majumder of 1 no Dabgram near Balaka Club, Ward No 23, PS- Siliguri, Dist Darjeeling & (4) Arindam Saha @ Shiva (24 yrs) S/O- Arun Saha of Rathkhola Math, Ward No 22, PS- Siliguri, Dist Darjeeling along with the following seized articles Viz:-

(i) One Lava keypad phone,(ii) One Lava keypad phone,(iii) One Samsung sky blue colour phone ,(iv) one Vivo golden colour phone,(v) one Vivo blue colour phone, (vi) One Samsung black colour phone. (vii) One Samsung light blue colour phone. (viii) one diary containing some notes of amount in words,(ix) One pocket diary, (x) one SBI passbook, A/C holder name Sushil Mandal A/C No- 20053581233, (xi) Cash amount Rs. 1,66,000/-(one lakh sixty six thousand only) denomination:- Rs. (2000/-X 8= Rs. 16,000/-, Rs. 500/-X 300= Rs. 1,50,000/-) .

I SI Uttam Baghira of Siliguri PS, SPC lodged this written complaint against the above noted accused four persons and Sujal Kr. Das @ Raju S/O- Subash Ch. Das of Ghugumali, PS- Bhaktinagar, Dist- Jalpaiguri, Tarak Rudra S/O- Lt. Sudhir Rudra of Haiderpara, PS- Bhaktinagar, Dist- Jalpaiguri, Piku Malakar S/O- Bakul Malakar of Chayanpara, PS- Bhaktinagar, Dist- Jalpaiguri, Naba, to the effect that, today on 24.05.2022 during my evening R/T mobile van duty, I received my reliable source information that, a gambling on IPL Cricket Game is going on inside a Salon name & styled as "SAVI" located at Subhashpally Bazar, under Siliguri PS with the help of their mobile phones, using App. Accordingly, I informed the matter to I/C Siliguri PS and as per his kind direction, myself along with my accompanied force left for the spot to verify the veracity of information. On arrived at 19.15 hrs. at the spot, found that the above noted accused persons are engaged in gambling with the help of their Mobile Phones using Apps with a view to wrongful gain and wrongful loss to them & other's by cash & online transaction. On seeing the police party they try to flee away from the spot but on hot chased, we apprehended the above noted four (04) accused persons and others managed to fled away from the spot. Accordingly, in presence of independent witnesses, I searched in the above noted Salon and accused persons and found the above noted articles from their possession. On interrogation, the arrested accused persons admitted their guilt and stated that they are directly involved in this Gambling last few years with their other associates namely Sujal Kr. Das @ Raju S/O- Subash Ch. Das of Ghugumali, PS- Bhaktinagar, Dist- Jalpaiguri, Tarak Rudra S/O- Lt. Sudhir Rudra of Haiderpara, PS- Bhaktinagar, Dist- Jalpaiguri, Piku Malakar S/O- Bakul Malakar of Chayanpara, PS- Bhaktinagar, Dist- Jalpaiguri and Naba who was fled away from the spot, with a view to their wrongful gain and wrongful loss to others and also cheating and dishonestly inducing delivery of property of others. Accordingly, I seized the above noted articles under proper seizure list as they failed to produce any valid lisenecy or documents for this type of IPL gambling in presence of independent witnesses and I

arrested the above noted four (04) accused persons u/s- 41 Cr.P.C. The search and seizure was made in between 19.50 hrs to 20.40 hrs.

Birendra Nath Majumder of 1 no Dabgram near Balaka Club, Ward No 23, PS- Siliguri, Dist Darjeeling & (4) Arindam Saha @ Shiva (24 yrs) S/O- Arun Saha of Rathkhola Math, Ward No 22, PS- Siliguri, Dist Darjeeling and accused persons under proper section of Law and Sujal K. Das @ Raju S/O- Subash Ch. Das of Ghugumali. PS- Bhaktinagar, Dist- Jalpaiguri, Tarak Rudra S/O- Lt. Sudhir Rudra of Haiderpara, PS- Bhaktinagar, Dist- Jalpaiguri, Piku Malakar S/O- Bakul Malakar of Chayanpara, PS- Bhaktinagar, Dist- Jalpaiguri, and Naba and arrange for its investigation.
