In producing herewith the arrested accused persons namely (i) Kurban Faraji (38 Yrs) S/O Late Achher Faraji of Vill Charkakmari, P.O, Saheb Nagar, P.S Sagarpara, Dist. Murshidabad (ii) Mahasen SK (45 Yrs) S/O Late Mayenudin SK of Vill Dairpara, P.O Saheb Nagar, P.S Jalangi, Dist. Murshidabad along with seized articles as per seizure list viz.

- (i) One Transparent plastic Packet containing Pinkish Color Tablets with "WY" inscribed on them, wrapped with yellow colored cello-tape weighing 3070 gms. said to be YABA tablets (contraband methamphetamine drug) marked as "Exhibit A", recovered from a compartment behind the driver's seat of truck bearing Reg. No. WB 25E/8677.
- (ii) One dark blue Color keypad Mobile Phone Styled as SAMSUNG with battery having tempered IMEI number along with Airtel 128K SIM having ICCID 0621EC8991000906016863805U from the right-hand front pocket of dark grey full pant of Kurban Faraji S/o Lt. Achher Faraji.
- (iii) Rs. 8000/- (500 X 15, 200 X 1, 100 X 3) Rupees Eight Thousand only from white colored check T-shirt front chest pocket (left side) of Kurban Faraji S/o Lt. Achher Faraji.
- (iv) One AADHAR Card in the name of Kurban Faraji S/o Lt. Achher Faraji having Adhaar No. 8402 7909 5632 from the right-hand front pocket of dark grey full pant of Kurban Faraji S/o Lt. Achher Faraji.
- (v) Rs. 21100/- (500 X 33, 200 X 1, 100 X 5, 50 X 78) Rupees Twenty-One Thousand One Hundred only/- from off white colored T shirt front chest pocket (left side) of Mahasen Sk S/o Lt. Mayenudin Sk.
- (vi) One Golden Color Touch Screen Mobile Phone styled as MI having IMEI1 868210032537207 & IMEI 2 868210032537215 along with one 4G Vodafone SIM card having ICCID 8991671723465234968SY and one JIO SIM Card having ICCID 89918400400206821683 from the left side pocket of black colored full pant of Mahasen Sk S/o Lt. Mayenudin Sk.
- (vii) One orange and purple colored Ashok Leyland truck bearing Reg. No. WB 25E/8677 along with its key.

NP/WB/25/032022/16301 date: 04.03.2022 in the name of Mahasen Sk valid upto 10.12.2022 I duly seized the same.

Thus, a reasonable belief having been formed that an offence has been committed in contravention of the section 8 C r/w 22 of the NDPS Act, 1985 (as amended) and that recovered articles were liable to be confiscated U/S-60 & 61 of the NDPS Act, 1985, the entire contraband of Methamphetamine were seized U/S- 43 of the NDPS Act, 1985 (as amended) under proper seizure list duly prepared by me. Took dated signature of the police witnesses (as no public witness is willing to stand as witness), both accused persons, signature of Inspector Shri Biswasroy Sarkar as gazetted officer and put my signature as seizing officer. Copy of seizure list given to the detained persons.

Thereafter all the seized articles have been properly labelled. Took signature of police personnel and both accused persons of contraband articles in the labels and marked accordingly. Thereafter, I arrested the above noted two persons after communicating their ground of arrest and issued arrest memo to them accordingly.

Under the above noted fact and circumstances a case under section 21(c)/22(c)/25/28/29 of NDPS Act, 1985 may kindly be started against the accused persons namely (i) Kurban Faraji (38 Yrs) S/O Late Achher Faraji of Vill Charkakmari, P.O, Saheb Nagar, P.S Sagarpara, Dist. Murshidabad (ii) Mahasen SK (45 Yrs) S/O Late Mayenudin SK of Vill Dairpara, P.O + P.S Jalangi, Dist. Murshidabad (iii) Bhugal Mullah S/o Lt. Kayamat Mullah of Paikmari, PS Domkal, Dist. Mursidabad and others involved in this racket.

Superiors of STF, WB have been apprised of the seizure, arrest and other proceedings made so far in this regard and in anticipation of the order of ADG STF, WB to take up the control of the case by STF WB, and S.I. Sangay Lama Tamang of Special Task Force, West Bengal, HQ at Siliguri will investigate the case.


