- (5) Tarun Roy, Son of Sri Chitra Mohan Roy of Purba Chayan Para, Eastern Bypass Dabgram – II, GP, P.S. Bhakti Nagar, Dist. Jalpaiguri and their associates and threatened us with dire consequences.

Sir,

I Smt. Anju Ghosh, Wife of Sri Swapan Ghosh, beg to lodge this complaint to the effect that I along with (1) Sri Satish Kumar Singh, S/O Late Chuhalal Singh of Baramohan Singh Jote, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling and (2) Sri Mintu Raj Brahma son of Nabin Chandra Brahma of Udalguri, Assam, are the joint absolute owner and physical possession of land measuring 12 Katha 8 chatak, of plot No. 214/927, recorded in R.S. Khatian No. 2844, corresponding to L.R. Khatian No. 1339, 1340 and 1341 of Mouza – Binnaguri.

JL. No. 03, Sheet No. 03, situated under Binnaguri Gram Panchayat P.O. Sahudangihat, P.S. New Jalpaiguri, District – Jalpaiguri, which we had purchased the same from (1) Sri Mithu Saha, (2) Sri Jaydeb Saha by virtue of a Registered Deed of sale Being No. 1/7298 dated 02/11/2015 which was registered in the office of the A.D.S.R. Rajganj, Dist – Jalpaiguri.

That after our purchased of aforesaid Land, the L.R. Khatian being No. 1339, 1340 and 1341 respectively published in our name under L.R. Settlement survey operation conducted

y the Government of West Bengal. Moreover, we regularly paid panchayat tax for over said and under Ref No. Assessment No 543 to the local authority. After purchased the said land we have constructed the concrete demarcation Boundary and Tin Shed Structure into our land and peacefully possessed the same since the said purchased.

That as we are the Government Employee posted in different places for observing our duty. Yesterday at about 9:00 AM, Morning when I came to my aforesaid land, I found that some anti social elements persons had demolished our concrete demarcation boundary wall along with our Tin shed structure stands in our land. On searching and enquiry from our neighbours we came to know that (1) Smt. Farah Naaz Alias Soma, (2) Tultul Banik, (3) Sakaluy, (4) Motai Barman, (5) Tarun Roy, and their associates have broken our demarcation wall and Tin Shed Structure forcefully and in illegal manner to grab our Land.

That the above named culprits are the land grabbers and they are also involved in other criminal cases. Moreover, at present they are absconding from their house. That Tultul Banik and Motai Barman illegally claimed Rs. 5,00,000 /- (Rupees Five Lacks) only, from us and threatened us that they will disturb us for our peaceful possession of land in future if we could not fulfil their demands.

I therefore, humbly requests you sir, to kindly enquire into matter and take necessary actions against the said culprits and oblige us.
