Respected Sir, I am Sujata Maiti wife of late Dr Ajit Kuma Maiti. I am resident of E.K.T.P Phase II, Abhyudoy housing, Flat B19/14 Kol-700107.

I had purchased a land measuring 8 katha of Mouza Thikrikata, P.S. Matigara pertaining to RS Plot No 1 and corresponding to part of L.R. plot No 1 by two separate sale deeds bearing nos 4608/2000 and 4607/2000.

I have been possessing this land peacefully since the date of purchase. khatian No is 1035. The land was subsequently converted from Rupal to Basti on 27.7.18.

After my husband's demise I moved to Kolkata. During the time of lockdown I have not able to visit my land.

Now Avijit Roy son of late Amol Roy, resident of Thikrikata, PO - Sushrutnagar, P.S. - Matigara, Dist - Darjeeling is restraining me to enter my own land.

Today when I went near my land at about eleven o'clock he along with his mother, wife, and relatives came out and started abusing me.

I had constructed a metal sheet linned room a year ago. when I went near the house Avijit advanced threateningly towards me as if to hit me. I being a widow and a lone was afraid of bodily harmed by Avijit

Avijit has also forged false papers of this land and trying to encroach the land on the strength of the said papers.

Also he has threatened me with dire consequences - that I should not step on this land.

As a widow I became frightened and pray for your help.

So I kindly request to take necessary action against Avijit and family for threatening me, not allowing me not to enter my land, extort money + forging false papers.
