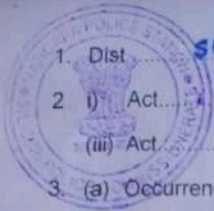

1. It is intimated that I Nardoj Limbu (Ex Serviceman) own a 05 Katha land in plot number LR 436 PS 264 in Khopalari, Manza-21 bearing Khuliyam Number 2853 (copy attached)

2. I have built home in the plot in 2013 and had been residing since then paying all the utility bills. However, the land grabbers are frequently threatening me of life and telling me to vacate my house or pay them money (in lieu) for not disturbing me. They are also reclaiming the sold land. They have been continuously threatening, harassing, vandalizing my boundary wall.
