WB-73G/2035 from our factory at Khaprail Road, Matigara for the buyer named Meera Barman, Madhya Sitalkuchi, Coachbehar vide Invoice Nos. 232/SSP/22-23 AND 013/PP/22-23 dated 22.05.2022. After delivering goods on 23.05.2022 our above named party Meera Barman paid total amount of Rs. 1,61,660/- to the said driver Mehboob Alam and simultaneously informed us and the said driver also confirmed the same. After reaching at Siliguri he did not made the payment to our office at India Bakery Gali, S.F. Road, Siliguri where he has to pay. After asking him for the payment received by him by our office staff and the person who hired the vehicle named Sudhir Shukla then firstly he said the money is kept at home I will bring the same at evening and then started telling lie that that money is missing from the vehicle.

It is very clear that he and his brother misappropriate and/or theft the money received from Smt. Meera Barman of coachbehar.

Your good office is, therefore, requested to lodge the F.I.R. and do the needful to recover the amount from the person did the theft.


