Sub: Illegal Occupancy of land and forgery by Land mafias

Respected Sir,

Myself Ravi Shankar Singh, S/o Baija Nath Singh, R/o Gandhinagar, Word No-43, P.S Bhaktinagar, Dist. Jalpaiguri. This is to inform you that one land with guard wall is situated in Matigara Tumbajote and has the registered in Name of my grandson i.e. Guddu Singh. The land was purchased on 13th June, 2005 vide deed no. 3720 from Smt. Manabasi Devi, W/o Sri Dipen Mahato and Smt. Lalmoti Devi, W/o Sri Naresh Mahato by some local broker i.e. Junglee Bin, S/o Biswanath Bin, Kishore Das @ Kishore Mukhia, S/o Late Basudev Das, Krishna Bhagat, situated within Pargana- Patharghata, Mouza-Toomba, R S khatian No. 789, LR Khatian No. 1556, Plot No. 1372, P.S. Matigara, Dist. Darjeeling. And my grandson Guddu Singh is the recorded owner of the above mentioned land. I'm his assigned registered Power of Attorney holder from 7th day of January, 2021, being Serial No. 156/2021, I V-142/2021 to look after the above mentioned land and for other purposes.

On 29th January 2021, when I went to the said land to look after the construction process as it was under construction. I saw a family was residing there in a roof tin shade. As I Raised objection as they were trespassers and residing there illegally, I came to know they are Radha Yadav, Durga Yadav alias Sapna Yadav and their sons namely Mohan Yadav, Krishna Yadav and others. By interrogating them, they replied that Junglee Bin and his brother –in-law Kishore das alias Kishore Mukhia has sold them our registered land in Rupees 8 lacks by forging them that it's vested land and if anybody come to take possession of it then they would see them.

I immediately had lodged an FIR in Matigara Police Station with all legal and valid documents but for some unknown reason Matigara Police Station has not given me any receipt copy of that said complaint. Then knocked the door of SPC also but no further action was taken for my land. Finding no other alternatives I frequently visited our land if any progress can be seen. Subsequently I went to meet with Junglee Bin and his brother –in-law Kishore Das alias Kishore Mukhia for vacant my land. There I come to know that they both along with one Ajay Mahato has already sold out that land to one namely Madhu sen, S/o Jogesh sen of Paschim Ashrampara, Siliguri and given registry by two unknown fake person as Rajesh Singh and Guddu Singh. I have the photocopy of their fake and manufactured deed, and I don't know that person who they are in the photographs and details of my Grandson. These all persons are their implant person. They have done a very big and cheap fraudulent conspiracy against us, deprived from the small shelter of our last savings. This land mafias should punished strictly for their these kind of forgery with the poor like us who have purchased small piece of plot of land by gathering one single rupees day by day. In this conspiracy 1) Junglee Bin, 2) Kishore Das and 3) Anil Mala are involve and no others. Only three persons are committed me offers.

This is my requested is to you kindly do the needful for my legal rights.
