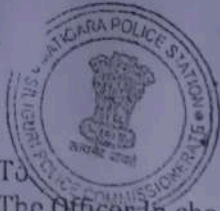

Subject: F.I.R

Sir,

I, ASI Prabir Roy of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 25.05.2022 at 13:55 hrs onwards I received information from my reliable source that some illegal digging of river bed materials is going on at Tarabari Ghat violating Govt. order. On receiving the information, I informed to O/C Matigara PS and as per kind order of O/C Matigara I along with other forces of Matigara PS rush to the spot to work out the information. On arrival at Tarabari Ghat found from a distance that some people are engaged in digging of river bed materials to a dumper bearing Reg. No. WB 73D/6275 violating Govt. order. However, seeing the Police party approaching towards them they fled away from the spot. Subsequently, I seized the above noted dumper bearing Reg. No. WB 73D/6275 under proper seizure list in presence of available witnesses.

Therefore, I pray before you that a specific case may kindly be started against the owner / driver of the seized vehicle bearing No. WB 73D/6275 and others under proper section of law and arrange for its investigation.
