I, Sharad Saraogi, Son of Late Sushil Saraogi, resident of Khalpara Siliguri P.S Khalapara TOP District Darjeeling would like to inform you that on 15/3/2022 I along with my wife went to en Saving Kingdom Carnival, situated at Salbari P.S Pradhannagar, District-Darjeeling, to watch "Kashmir File" movie. That beside our seat one person namely, Pravin Agarwal, having phone number 94745-91713, resident of E-4, Gulmohar Apartment, ITI Road, Siliguri, P.S. 1.00:10 ha Bhaktinagar, District- Jalpaiguri, was sitting along with his wife having seat no. C/7 and C/8, Screen No. 2. That at the time when the national anthem was played on the screen, Pravin Agarwal and his wife did not stand and were gossiping. To this, as a due respect to our nation, I politely requested them to stand. To this, he used abusive language against me saying - "tu bada deshbhakt hai". I kept silent and did not oppose.

After this during the said movie, Pravin Agarwal was constantly talking over phone and back to our seat after the interval ended. Throughout the movie, said Pravin Agarwal and his wife were passing wrongful remarks and were continuously discussions. to disturb but they did not listened. After this, when the movie ended and lights were on and I and my wife were ready to come out of the movie. dr 24.03.22 deliberately put his leg infront so that I stumble and because of this I stumbled and was about to fall. To this, Praving Agarwal and his wife started to laugh. When I opposed to this, Pravin Agarwal caught hold of my collar and slapped me and started to assault me. When my wife tried to stop him, Pravin Agarwal used abusive language against her and took her spectacles and mobile and threw it away. He also touched her inappropriately disrobing her modesty and my wife cried for help. That I immediately stopped him and even the audience tried to restrain Pravin Agarwal and after the intervention of the audience the matter was brought under control. That I and my wife have suffered immense humiliation and my wife suffered immense mental trauma due to Pravin Agarwal and his wife.

That there has been a delay in lodging this F.I.R. as I and my wife did not knew the name of Pravin Agarwal earlier. I tried to find it out and at last I saw him on 21.5.2022 in a blood ctor-Incidohation camp at International Market, Siliguri. I tried to get his details and got his visiting Inspection Nag Card and Came to know his name and other details on 23.5.2022. Therefore, I am lodging Prante: Control Solice Control Co action against Pravin Agarwal and his wife.
