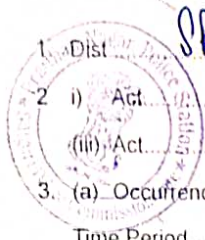

With due respect it is to inform you that I Sri.Ram Prashad Kundu, S/O Lt.Rakhal Chandra Kundu, residence of Samarnagar ,Champasari , PO & PS - Pradhannagar, District- Darjeeling, I am the constituted attorney holder of Sri.Akhil Chandra Saha, S/O Lt.Chattradhar Saha , resident of Samarnagar PO.Champasari, PS- Pradhannagar, District- Darjeeling.

That Akhil Chandra Saha is the accutual and recorded owner of the land measuring 5 katta , or 08.25 Decimal , Mouza - Kalkut , JL.No.44, Khatian No- 4888, RS Plot no-439, LR Plot no- 683, LR Khatian no - 1766 & 2647 , Touzil no-91, PS- Pradhannagar, District- Darjeeling and also my own brother-in-law.

Almost 5years ago two person, namely Mr. DHIMAN BARMAN, S/O PULIN BARMAN. And Mr. SHYAMAL BISWAS. S/O AMAL BISWAS, Of Samarnagar, Champasari, Siliguri ,came to my brother-in-law's above mentioned property and forcefully occupied that property without taking any land registration from me or from my brother-in-law .After that when I requested them many times to vacant that property but they refused to do so and also they threatened me that they will kill me and physically harassed me . As seeing their this type of behavior it's my assumption that may be they made falls papers of this land. So I lodged a complained against them in your Police Station but no action was taken against them on that time. After that on 30/12/2019 the original copy of land registration department along with that complained was destroyed by fire from my shop .That time I recorded a FIR GD NO- 1806 from your P.S., which i attached with this FIR and also attached a copy of Online Searching Record as per Banglabhumi ,dated 19-02-2022, time-16:16:11.
